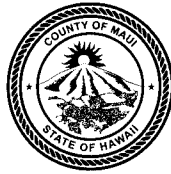

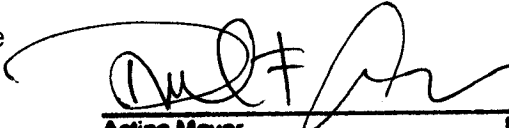

**SUBJECT: MAKENA RESORT – CHANGE IN ZONING COMPLIANCE  
WITH CONDITIONS RELATING TO ACCESS FOR PARKS AND

In response to your January 25, 2012 letter, please find maps attached, which identifies the following:

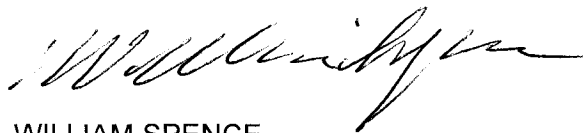
1. The area comprising Maluaka Beach, and all associated Tax Map Keys [TMK(S)] (Exhibit 1);
2. The portion of TMK: (2) 2-1-06:057 that is zoned PK-1 Neighborhood Park District (Exhibit 2);
3. The portion of TMK(S): (2) 2-1-06:057 and 063 zoned PK-4 (Exhibit 2);
4. The area discussed by the Planning and Land Use Committee at its meetings of March 18, 2004, April 12, 2004, and April 14, 2004, to be designated for the park expansion (Exhibit 2); and
5. The area proposed by ATC Makena Holdings, LLC for the park expansion (Exhibit 3). Note that the map attached to the June 29, 2009 transmittal letter from Dowling Company to Patrick Matsui of the Department of Parks and Recreation, dated May 28, 2009, has been superimposed on the imagery map of the area.
