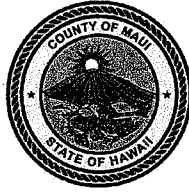

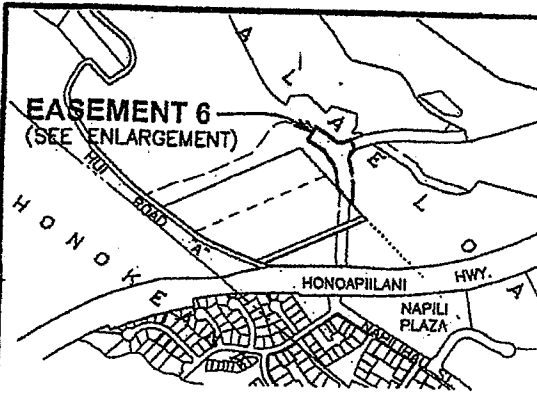

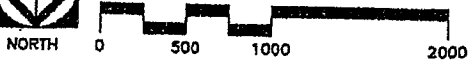


EASEMENT 6
