**SUBJECT: RESOLUTION NO. 21-171 REFERRING TO THE
PLANNING COMMISSIONS A PROPOSED BILL
RELATING TO WETLANDS RESTORATION AND
PROTECTION**

Resolution No. 21-171 was adopted on November 5, 2021 to transmit a proposed bill to the three planning commissions for their review and recommendation; it was sent to the Planning Department (Department) by transmittal dated November 9, 2021. The Department has since gathered agency comments and conducted research into this important and complex subject. As a result, the Department is currently preparing revisions to the proposed bill as well as background information on options for further wetlands protection.

The public hearings with the three planning commissions will be scheduled soon; however, it is likely the Department will not meet the deadline mandated by the County Charter. The Department respectfully requests that your CARE Committee wait to schedule this item for consideration until the Department has completed its review process, the commissions have held their public hearings on the bill and provided their recommendations, and the Department transmits a package back to the County Council.
