SUBJECT: UPDATES ON RECOVER EFFORTS IN RESPONSE TO THE AUGUST 2023 WILDFIRES ON MAUI ISLAND (DRIP-2(12))

This responds to your correspondence dated October 20, 2023.

Question 1:

The USAR or Urban Search and Rescue team that responded to critical incidents such as 9/11 and Hurricane Katrina also responded to assist in the search. They used canines that are specifically trained in the recovery of incidents of this magnitude. In addition, we also used data from various reports and forensic anthropologists. The forensic anthropologists used were through the Department of Defense and are subject matter experts in situations like this, since they recover folks that are POWs and MIAs.

Question 2:

We are at 99% of the search we will be at 99% until we are confident that everyone has been recovered. We made a recovery approximately two weeks ago, and the identification for that individual was just made yesterday. That being said, we still have five open cases and are working diligently to ascertain whether those individuals were lost in the fire or not.

We have been able to release approximately 90 of the 99 that we have recovered to the funeral homes for their families. After identification, families are notified and the process is explained to them. We are optimistic and hopeful that everyone lost is recovered from this incident and will be returned to their families.
