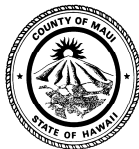

May I please request the following:


1. A timeline of the grant agreement, Grant Amendment 1, and the related budget amendment requested in Bill 95 (2025).
