Na Hale O Maui (NHOM) is a nonprofit 501(c)3 created “To secure and preserve a permanent supply of affordable housing alternatives for low and moderate income households in Maui County.” We encourage efforts to increase the amount of affordable housing in Maui County. We appreciate the opportunity to engage in discussions to explore potential solutions to the affordable housing crisis facing our community.

Each of the above captioned proposals (HHT-4, 5 & 6) appear to have merit. We read the information that other municipalities shared – their affordable housing needs, experience, regulations, policies, challenges and successes – demonstrate that change, while often stressful, can be implemented to increase housing in a meaningful way. Translating and incorporating the best practices of other jurisdictions, where it makes sense for our community, could simplify and shorten our path to more affordable housing, sooner.

Kauai County’s Affordable Housing Development Strategy and Resolution No 2016-54 Draft were particularly interesting, as they outline S.M.A.R.T. (Specific, Measurable, Achievable, Relevant; and Timely) goals with action steps to the goal of increased numbers for affordable housing, sooner.

Thank you for continuing to consider the most efficient and effective methods to increase affordable housing in Maui County.
