

# Resolution

**No. 26-33**

**ACTING ON THE NOMINATION OF STANFORD KEITH LANIAS  
TO THE MAUI REDEVELOPMENT AGENCY**

WHEREAS, the Maui Redevelopment Agency was formed and operates with five members under Section 2.40.050, Maui County Code and Section 53-2, Hawaii Revised Statutes; and

WHEREAS, one vacancy will occur on the Maui Redevelopment Agency when existing term expires on March 31, 2026; and

WHEREAS, by correspondence dated January 29, 2026, Mayor Richard T. Bissen, Jr., notified the Council he nominated Stanford Keith Lanias listed in Exhibit "A," as attached, to fill the vacancy; and

WHEREAS, the nomination is made in accordance with Section 2.40.050, Maui County Code, and Section 53-2, Hawaii Revised Statutes; and

WHEREAS, Subsection 53-2(a), HRS, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17) requires the Council to approve or disapprove the Mayor's nomination within 30 days after the Mayor submits the name of the nominee to the Council and, if the Council disapproves the nominee, to immediately notify the Mayor and the Independent Nomination Board of the Council's action; now therefore,

**BE IT RESOLVED** by the Council of the County of Maui:

1. That it approves the appointment of the person listed in Exhibit "B," as attached, as a member to the Maui Redevelopment Agency for a term expiring on March 31, 2031;
2. That it disapproves the appointment of the person listed in Exhibit "C," as attached, as a member to the Maui Redevelopment Agency as nominated by the Mayor;
