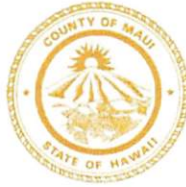

**SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2024 BUDGET  
(DEPARTMENT OF FIRE AND PUBLIC SAFETY,  
ADMINISTRATION PROGRAM AND TRAINING PROGRAM)**

On behalf of the Department of Fire and Public Safety, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, DEPARTMENT OF FIRE AND PUBLIC SAFETY, ADMINISTRATION PROGRAM AND TRAINING PROGRAM."

The purpose of the proposed bill is to amend the Fiscal Year 2024 Budget, Department of Fire and Public Safety, Administration Program by decreasing the equivalent personnel by 2.0 and the appropriation under Category A by \$82,884 and increasing the equivalent personnel and the appropriation under Category A for the Training Program in the same amount.

The Department of Management approved a reorganization of the Department of Fire and Public Safety in December of 2022. The majority of positions impacted were reallocated in the Fiscal Year 2024 Budget, but two positions were not. One Inventory Maintenance Technician (P-25941) and one Storekeeper I (P-30992) need to be reallocated from the Administration Program to the Training Program to complete the reorganization.
