SECTION 1. Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended "Fiscal Year 2025 Budget", Section 3.B.12.c.(3)(viii), Office of the Mayor, Economic Development Program, Grants and disbursements for culture, arts, and tourism, Maui Film Festival is amended to change the appropriation title to "Maui Economic Development Board, Inc. for the Wailuku Film Festival", to read as follows:


