A BILL FOR AN ORDINANCE AMENDING APPENDIX A

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4988 Bill No. 36 (2019), Draft 1, as amended, "Fiscal Year 2020 Budget", Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for Fiscal Year 2020, is hereby amended as it pertains to item U. Employee Parking Fees Fund, by increasing the proviso for parking lot improvements, lighting, and security measures, by \$15,000, to read as follows:
