A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE STATE OF HAWAII, DEPARTMENT OF THE ATTORNEY GENERAL, REGARDING GRANT OF FUNDS FOR THE STOP VIOLENCE AGAINST WOMEN FORMULA GRANT PROGRAM

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Purpose. The Department of the Attorney General, State of Hawaii, has awarded a grant to the Department of Police, County of Maui, (Project Number 16-WR-06), attached hereto and incorporated herein by reference as Exhibit "1", for the term April 1, 2018 through March ~~4~~³¹, 2019, in the amount of FIFTY-FIVE THOUSAND THREE HUNDRED EIGHTY DOLLARS (\$55,380), as set forth in Exhibit "A" to Exhibit "1". The County of Maui is required to provide an Agency Match of EIGHTEEN THOUSAND FOUR HUNDRED SIXTY DOLLARS (\$18,460), which was provided in the Fiscal Year 2019 Budget for the Department of Police.

Section 2.20.020, Maui County Code, provides that, unless authorized by ordinance, the Mayor shall not enter into any intergovernmental agreement or any amendment thereto which places a financial obligation upon the county or any department or agency thereof.

SECTION 2. Council authorization. Pursuant to Section 2.20.020, Maui County Code, the Council of the County of Maui hereby authorizes the Mayor to execute the Agreement, accept the grant funds and provide the agency matching funds, and execute all other necessary documents relating to the Agreement, and any amendments thereto.

SECTION 3. Effective date. This ordinance shall take effect upon its approval.
