He has served as Visiting Professor at Fukuoka University, Fukuoka, Japan, Beijing Foreign Studies University Law School and the University of International Relations Law School, Beijing, China. As Chief Judge, Judge Raffetto served as a member of many Judiciary Committees for the improvement of the justice system in Hawaii, including the Committee on Jury Innovations for the 21st Century (Chair). He created and served as presiding judge for the Maui/Molokai Adult Drug Court program, a very successful rehabilitation program for drug addicted offenders in the criminal justice system.

Chief Judge Raffetto also created and carried out the "International Court Observer Program" in which he invited foreign law professionals to visit his Court in order to observe and learn about, first hand, the US justice system; in particular, observe a complete jury trial. Participants in the program over the years included law professionals from Russia, Mongolia, Thailand, Germany, Iraq and Afghanistan. Most recently, just prior to Judge Raffetto's retirement, all seven of the Chief Military Judges from the seven Military Judicial Districts of Afghanistan, and the Chief Military Judge, came from Afghanistan to observe operations in Judge Raffetto's court in Maui, Hawaii for one week.

After serving 3 years as a member of the US Marine Corps. Reserve, Chief Judge Raffetto served 21 years as a US Navy Reserve legal officer (Judge Advocate General's Corps.) actively engaged in all aspects of military justice, operational law, and international law. During his Navy service, Chief Judge Raffetto was appointed and served for five years as Military Judge for US Navy and Marine Corps. Trial Judiciary. As a Military Judge he presided over court martial proceedings in Japan, Guam and the US. He retired 2001 with the rank of CAPTAIN (O-6) and was awarded the Meritorious Service Medal.

Chief Judge Raffetto has served for many as Adjunct Instructor with the US Defense Institute of International Legal Studies (DIILS) presenting training seminars in many nations around the World on subjects related to rule of law, military justice reform, UN peacekeeping operations, human rights, and many other related subjects.

Chief Judge Raffetto has also served for many years as an independent consultant and Senior Fellow for the Geneva Center for the Democratic Control of Armed Forces (DCAF), a Swiss inter-governmental organization located in Geneva, Switzerland. For DCAF he researched and presented papers and lectures on military law reform, ombudsman in the military, civilian control of the military, human rights in the military, anti-corruption and related subjects, at venues such as the UN Development Project conference in the Kingdom of Tonga, international conferences at Moscow, St. Petersburg, and in consultation with the Parliament of Indonesia at Jakarta, Indonesia, the Republic of Armenia and Kiev, Ukraine. Most recently, in 2013-14, for DCAF Judge Raffetto traveled to the Republic of Armenia and presented a program on Human Rights in the US Military as a part of an on-going training effort in that nation to create it's independent armed forces, and presented a program on the structure and history of the US National Guard for the Defense Ministry of Ukraine in Kiev, in support of Ukraine's effort to re-establish a national guard.

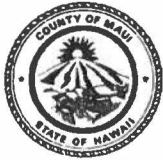
