SUBJECT: **MAUI'S LONG-TERM RECOVERY OPERATIONS** (DRIP-9(4))

At its meeting of March 18, 2026, the Council's Disaster Recovery, International Affairs, and Planning Committee discussed Maui's long-term recovery operations, including Lahaina's recovery efforts.

In 2024, you noted that the water distribution systems served by the Lahaina and Mahinahina Water Treatment Facilities are connected and water can be transmitted from the Mahinahina system to the Lahaina system.

If water flow was transmitted from the Lahaina system to the Mahinahina system at the time of the August 2023 Maui wildfires, would the drinking water in the Mahinahina system have been compromised because of the connection? Please explain.
