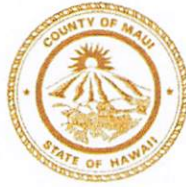

The County of Maui's Governmental Accounting Standards Board (GASB) Statement No. 75 requires that the County of Maui conducts an audit of the schedule of changes in fiduciary net

position by the County of Maui and related notes to the schedule of the Hawaii Employer-Union Health Benefits Trust Fund ("EUTF") and an examination report on census data from actuarial information received by the EUTF's actuary for the fiscal years ending June 30, 2023, 2024, and 2025. KKDLY LLC ("KKDLY"), the contract auditor for ERS has been contracted by the Office of the Auditor, State of Hawaii, to conduct the audits of the above-mentioned schedule and information. In addition, the purpose of the proposed resolution is to provide for payment by the County of Maui to the contract auditor as authorized under section 23-3.5, Hawaii Revised Statutes, for a fee of \$4,200.00, \$4,300.00, and \$4,400.00 for fiscal year ending June 30, 2023, 2024, and 2025, respectively. The Memorandum of Understanding ("MOU"), attached hereto and incorporated herein as Exhibit "1," places a financial obligation on the County and is intended to be executed between the County of Maui and State of Hawaii, Office of the Auditor.
