





Testimony on AH-14 Comprehensive Affordable Housing Plan Tuesday, March 23, 2021

Testimony to the Affordable Housing Committee March 23, 2021

Dear Chair Gabe and Council members,

I am Stan Franco, President of Stand Up Maui and speak on their behalf. We thank the Maui County Council and Hawaiian Community Assets for getting us to this point in the development of a Comprehensive Affordable Housing Plan for the residents of Maui, Molokai and Lanai.

I have reviewed the draft and in consultation with others in Stand Up Maui have these few comments:

- 1. We agree that we must all be on board as a community to make the final plan a reality.
- 2. We like concepts like a Public Review Committee, Individual Savings Accounts (IDAs) and the expansion of the Affordable Housing Fund to cover cultural, environmental, and archaeological assessments.
- 3. We would like more discussion on the following:
 - a. A clear understanding of the terms affordable housing and workforce housing.
 - b. A system like a Land Trust to keep homes built under the Plan affordable long term (We remember the Front Street Apartments issue).
 - c. A centralized Housing Eligibility List.
 - d. A legal system to prioritize affordable homes for local residents over outsiders.

- e. Use of local sourced materials and innovative construction methods to lower housing costs.
- f. A financial plan for the County to purchase land for affordable housing and pay for infrastructure and implementation costs.
- g. A Housing Authority or like entity to implement the plan. The people of Maui County will not accept another report for someone's shelf.
- h. Mortgage funds with terms favorable to residents.
- i. Adaptive use of vacant commercial buildings.
- j. A housing plan for individuals and families who are houseless.

Our preliminary comments are made to continue the dialogue to reach our goal to have a final plan by June 30, 2021. We appreciate the first step to create the homes our people want, need, and deserve. Thank you.
