- 3. Has the three-year time limitation under Section 3.47.110(C), Maui County Code, been triggered for delinquent taxpayers? Please explain and include in your explanation whether the response differs for certain classes or types of County TAT taxpayers. Is there a

> mandatory interest, penalty, or fine for delinquent payments, or is a penalty or fine assessed at the Director's discretion? How much is the penalty or fine, and will the Department make an attempt to collect it?

4. Has the Department received a list of State TAT payers from the State of Hawaii? If not, will the Department be requesting a list to help reconcile the County TAT payments it should be receiving?
