A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.38,
MAUI COUNTY CODE, RELATING TO ADMINISTRATION OF THE HAWAIIAN
CULTURAL RESTORATION REVOLVING FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. This Ordinance's purpose is to establish the Director of 'Ōiwi Resources as administrator of the Hawaiian Cultural Restoration Revolving Fund. Under Section 8-21.3, Revised Charter of the County of Maui (1983), as amended, the Director of 'Ōiwi Resources is mandated to: "Promote healthy ecosystems through natural-cultural resource regeneration, protection, and sustainable utilization." Therefore, administration of the Hawaiian Cultural Restoration Revolving Fund is an appropriate task for the Director.

SECTION 2. Section 3.38.030, Maui County Code, is amended to read as follows:

"3.38.030 Administration; report to the council. A. The director of finance [shall] must establish a separate account to record all revenues credited to[,] and expenditures made from[,] the revolving fund.

B. Appropriations from the fund [shall] must be by ordinance passed upon a vote of the council.

C. On or before March 1 of each year, the director [shall] of 'ōiwi resources must transmit to the council a detailed report of the fund during the preceding year.

D. The director of 'ōiwi resources must administer the fund."

SECTION 3. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 4. This Ordinance takes effect on July 1, 2024.


