A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM, MAKAWAO-PĀ'IA-HA'IKŪ ECONOMIC DEVELOPMENT, ENVIRONMENTAL, AND CULTURAL PROGRAMS, REMOVING THE CONDITIONAL LANGUAGE FOR KAIZEN GROUP INC. AND INSERTING CONDITIONAL LANGUAGE FOR NĀ MAKA O MĀLIKO

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5816, as amended, "Fiscal Year 2026 Budget," Section 3.B.12.c.(2).(xii)(f), Office of the Mayor, Economic Development Program, Grants and disbursements for business development and technology, Makawao-Pā'ia-Ha'ikū Economic Development, Environmental, and Cultural Programs, is amended to update the conditional language to delete "Kaizen Group Inc., for a surfing event" and insert "Nā Maka O Māliko to support the preservation, restoration, and maintenance of lands at and adjoining Māliko Gulch, Maui," to read as follows:




