

RELATING TO THE APPOINTMENT OF MANDY SAITO TO THE URBAN DESIGN REVIEW BOARD FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated April 3, 2019, Mayor Michael P. Victorino notified the Council that he nominated Mandy Saito (Engineer) as an Alternate to the Urban Design Review Board for the County of Maui for a term expiring on March 31, 2024, to fill a vacancy created when Darren Okimoto became a regular member, pursuant to Sections 2.26.030 and 2.40.100, Maui County Code ("MCC"), and Section 13-2, Revised Charter of the County of Maui (1983), as amended ("Charter"); and


WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nominee within sixty days after the Mayor submits the nominee to the Council due to death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Mandy Saito (Alternate-Engineer) to serve on the Urban Design Review Board for a term expiring on March 31, 2024; and
2. That the Council expresses its gratitude and appreciation to Mandy Saito for her willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
