Chair and Members:

Your Budget and Finance Committee, having met on February 14, 2017, makes reference to County Communication 17-42, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES – SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2017, COUNTYWIDE SEWER CAPITAL IMPROVEMENT RESERVE FUND."

The purpose of the proposed bill is to amend Appendix A of the Fiscal Year 2017 Budget, relating to Countywide Sewer Capital Improvement Reserve Fund (Section 9-14, Revised Charter of the County of Maui (1983), as amended), by adding 1) a proviso for \$110,000 for the Lahaina Wastewater Pump Station No. 3 Modifications; and 2) a proviso for \$1,010,000 for the Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement.

At the request of the Chair of your Committee, the Department inquired with the State of Hawaii's Water Pollution Control Branch whether additional State Revolving Loan Funds were available for the Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement project.

By correspondence dated February 3, 2017, the Budget Director transmitted the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO ESTIMATED REVENUES; DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, SEWER KIHEI NO. 16 PUMP STATION

The purpose of the proposed bill is to amend the Fiscal Year 2017 Budget by 1) increasing Other Intergovernmental by \$1,010,000; 2) increasing Carryover/Savings from the Sewer Fund by \$110,000; 3) adding an appropriation of \$1,010,000 under the Department of Environmental Management, Kihei-Makena Community Plan Area, Sewer, State Revolving Loan Fund, for the Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement project; and 4) adding an appropriation of \$110,000 under the Department of Environmental Management, West Maui Community Plan Area, Sewer, Sewer Fund, for the Lahaina Wastewater Pump Station No. 3 Modifications project.

2. A proposed bill entitled “A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX C – CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, KIHEI NO. 16 PUMP STATION REHABILITATION AND FORCE MAIN REPLACEMENT, LAHAINA WASTEWATER PUMP STATION NO. 3 MODIFICATIONS.”

The purpose of the proposed bill is to amend the Fiscal Year 2017 Budget, Appendix C, Capital Improvement Projects, by adding under the Department of Environmental Management: 1) an appropriation of \$1,010,000 under the Kihei-Makena Community Plan Area, for the Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement project and a description of the project; and 2) an appropriation of \$110,000 under the West Maui Community Plan Area, for the Lahaina

3. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. 4320, BILL NO. 48 (2016), AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO INTERGOVERNMENTAL AGREEMENTS FOR LOANS FROM THE STATE OF HAWAII'S WATER POLLUTION CONTROL REVOLVING FUND FOR VARIOUS WASTEWATER PROJECTS, FISCAL YEAR 2017 BUDGET ORDINANCE."

The purpose of the proposed bill is to amend the Intergovernmental Agreement for loans from the State of Hawaii's Water Pollution Control Revolving Fund for Fiscal Year 2017 by adding \$1,010,000 for the Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement project.

4. A Certification of Additional Revenues, dated February 6, 2017, for \$110,000 in Carryover/Savings from the Sewer Fund.

Your Committee notes in the Fiscal Year 2016 Budget, \$1,600,000 from the Sewer Fund was appropriated for the Lahaina Wastewater Pump Station No. 3 Modifications project. Contract C6184, in the amount of \$1,600,000, was awarded to Betsill Brother LLC and executed in December 2016.

Your Committee further notes in the Fiscal Year 2016 Budget, \$4,400,000 from the State Revolving Loan Fund was appropriated for the Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement project. Contract C6177, in the amount of \$4,400,000, was awarded to Goodfellow Bros., Inc. and executed in December 2016.

The Budget Director said the Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement project includes a replacement of a 5,073 feet, 6-inch diameter force main within Makena and Wailea Alanui Drives.

She said the Lahaina Wastewater Pump Station No. 3 Modifications project includes construction upgrades that are required modifications to the existing pump station originally constructed in 1994.

The Director of Environmental Management said the bids for both projects were higher than the amount appropriated in the Fiscal Year 2016 Budget. He confirmed the availability of State Revolving Loan Funds for the Kihei project.

A representative from the Department of Environmental Management, Wastewater Reclamation Division, explained to your Committee the Lahaina project is located in Wahikuli, near Fleming Road. The additional funds for the project will be used to upgrade the pump and generator system at the pump station.

The representative stated the shortfall for the Kihei project is because of higher than anticipated bids for the project. He said the project to replace and modify the aging force main, by making it shorter, will improve its efficiency. Since the force main is part of the pumping system, the project also includes changes to the pumps. He said the current system is near obsolete and poses a higher risk for spills.

Your Committee voted 6-0 to recommend passage of the proposed bills on first reading and filing of the communication. Committee Chair Hokama, Vice-Chair White, and members Atay, Cochran, King, and Sugimura voted "aye." Committee members Carroll, Crivello, and Guzman were excused.

Your Committee is in receipt of a revised proposed bill, as noted in item 1 above, approved as to form and legality by the Department of the Corporation Counsel, incorporating nonsubstantive revisions that take into account prior amendments to the Fiscal Year 2017 Budget.

A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. 4320,  
BILL NO. 48 (2016), AUTHORIZING THE MAYOR OF THE  
COUNTY OF MAUI TO ENTER INTO INTERGOVERNMENTAL AGREEMENTS  
FOR LOANS FROM THE STATE OF HAWAII'S WATER POLLUTION  
CONTROL REVOLVING FUND FOR VARIOUS WASTEWATER PROJECTS,  
FISCAL YEAR 2017 BUDGET ORDINANCE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4226, Bill No. 33 (2015), authorized the County of Maui to enter into an intergovernmental agreement for a State Water Pollution Control Revolving Fund Loan in the amount of \$4,400,000 for the Kihei No. 16 Pump Station Rehabilitation and Force Main Replacement project. The project requires an additional \$1,010,000 in funding.

SECTION 2. Ordinance No. 4320, Bill No. 48 (2016), is amended by amending Section 1 to read as follows:

"SECTION 1. Request for Loan. The County of Maui, pursuant to Section 342D-83 through Section 342D-87, Hawaii Revised Statutes, has submitted an application for State Water Pollution Control Revolving Fund Loans ("SRF loans") to the Director of the Department of Health, State of Hawaii, to finance the following projects:

- a. Kulanihakoi Street Recycled Water Line  
Extension ..... \$1,700,000
- b. Lahaina Wastewater Reclamation Facility (WWRF)  
Modifications, Stage 1A..... \$12,500,000
- c. Sheraton Wastewater Pump Station Modifications..... \$1,000,000
- d. Countywide Wastewater Reclamation Facility (WWRF)  
Chlorination System Upgrade ..... \$2,000,000

- e. Wailuku-Kahului Wastewater Reclamation Facility  
Solids Building Renovation .....\$1,000,000
- f. Kihei No. 16 Pump Station Rehabilitation  
and Force Main Replacement..... \$ 1,010,000

(collectively, "Projects").

Under the terms and conditions anticipated with regard to each such SRF loan, the County shall repay, over a term of twenty years, the principal amount, which shall not exceed the amount of each such loan stated above, at a fixed rate of interest that shall not exceed the Bond Buyer's 20-year general obligation bond issue."

SECTION 3. Material to be repealed is bracketed. New material is underscored.

SECTION 4. This ordinance shall take effect upon its approval.
