A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, APPENDIX A, PART I,
DEPARTMENT OF MANAGEMENT, PRIVATE DONATIONS,
NEW APPROPRIATION OF \$10,000

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5816, "Fiscal Year 2026 Budget," Appendix A, Part I, Grants and Restricted Use Revenues– Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2026, is amended to add an appropriation for the Department of Management, entitled "Private Donations", in the amount of \$10,000, to read as follows:


