Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on June 7, 2023, and reconvened on June 9, 2023, makes reference to Resolution 22-160, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 4056092 OF CRAIG CLOVE."

Resolution 22-160's purpose is to authorize settlement of the claim, filed on March 16, 2020. The claim alleges bodily injuries sustained near mile marker 19 on Honoapi'ilani Highway, Lāhainā, Maui, Hawai'i, on February 19, 2020, from a collision involving a County fleet vehicle.

By correspondence dated June 16, 2022, the Department of the Corporation Counsel provided a copy of the claim.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided an overview of the claim and explained that the parties had reached a negotiated settlement, pending Council approval.

The Deputy Corporation Counsel requested an executive meeting to discuss confidential information related to the claim.

Your Committee voted to convene an executive meeting, closed to the public, to consult with legal counsel in accordance with Sections 92-5(a)(4) and 92-5(a)(8), Hawaii Revised Statutes.
