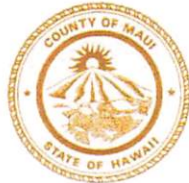

**SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2024 BUDGET
(CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF
PARKS AND RECREATION, KĪHEI-MAKENA COMMUNITY
PLAN AREA)**

On behalf of the Department of Parks and Recreation, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, REVENUES; CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF PARKS AND RECREATION, KĪHEI-MAKENA COMMUNITY PLAN AREA; AND APPENDIX C, DEPARTMENT OF PARKS AND RECREATION, KĪHEI-MAKENA COMMUNITY PLAN AREA."

The purpose of the proposed bill is to 1) increase Carryover/Savings, General Fund and Total Estimated Revenues by \$800,000; 2) amend Capital Improvement Projects, Department of Parks and Recreation, Kīhei-Makena Community Plan Area, Parks and Recreation, by adding a new appropriation under General Fund entitled "Kīhei Community Center Improvements" in the amount of \$800,000 and increase the Total Capital Improvement Project

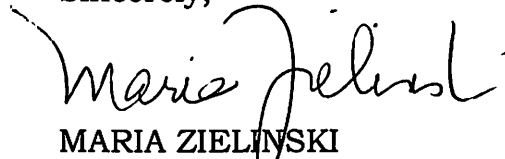
Appropriations and Total Appropriations by the same amount; and 3) amend Appendix C, Department of Parks and Recreation, Kīhei-Makena Community Plan Area, by adding a new project and project description for “Kīhei Community Center Improvements” in the amount of \$800,000.

Funds for this project were included in the FY 2023 Budget, and it was bid on November 8, 2023. The construction contract was partially encumbered with these funds, but the lowest qualified bid was \$1,163,000. Additional funds are being requested for FY 2024 to fund the remainder of the contract.

These funds will be used for the remainder of the Kīhei Community Center air conditioning replacement project. The air conditioning system at the community center is currently failing and does not have the capacity to cool the building. Completion of this project will reduce maintenance costs and will benefit the public by providing adequate cooling for larger community events.
