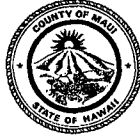

**SUBJECT: STATUS OF GRANTS UNDER THE DEPARTMENT OF  
WATER SUPPLY AND BENCHMARKS FOR GRANTEE  
PERFORMANCE (WR-9)**

The Water Resources Committee is in receipt of a Miscellaneous Communication dated May 22, 2017, from the County Clerk, reporting that on May 19, 2017, the Council referred the matter relating to the status of grants under the Department of Water Supply and benchmarks for grantee performance.

Section 3.36.120, Maui County Code, provides:

- A. The agency shall monitor every grant to ensure compliance with this chapter.
- B. Within eight weeks after the end of the fiscal year, the agency shall transmit to the mayor and council an evaluation of every grant which was appropriated during the fiscal year. The report shall contain a summary of whether each grant attained the intended results in the manner contemplated.


Maui County Code. Please also explain the benchmarks used to evaluate grantee performance. I would appreciate receiving your response to this request by **August 11, 2017**.
