## RELATING TO THE APPOINTMENT OF EMMANUEL BALTAZAR TO THE COST OF GOVERNMENT COMMISSION

WHEREAS, there is a vacancy on the Cost of Government Commission due to the resignation of Gabriel Hoeffken on February 2, 2016; and

WHEREAS, Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Chapter 2.41, Maui County Code, outline commission nomination procedures for the Mayor and the Council; and

WHEREAS, the Mayor did not submit a nomination to the Council by the deadline of March 3, 2016; and

WHEREAS, pursuant to Section 2.41.050, Maui County Code, in the event the Mayor fails to submit the name of a nominee within the time provided by law, the Council has sixty days from the expiration of the time so provided to nominate and approve an individual to fill the vacancy; and

WHEREAS, the Council is currently within its sixty-day period, which will expire on May 2, 2016, to nominate and approve the appointment of an individual to fill the vacancy; and

WHEREAS, Emmanuel Baltazar has indicated a desire to be appointed to the Cost of Government Commission for a term expiring March 31, 2019, and has submitted a completed application form with the information required by Section 2.41.020, Maui County Code; now, therefore,


BE IT RESOLVED by the Council of the County of Maui:
