Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on October 17, 2023, makes reference to Resolution 23-113, entitled “AUTHORIZING SETTLEMENT OF CLAIM NO. 4076130 OF HANSEN OHANA SECURITY LLC (ROBERT HANSEN).”

Resolution 23-113’s purpose is to authorize settlement of the claim, filed on March 30, 2022, in the amount of \$14,982.67. The claim alleges damages to the claimant’s property located at 52 Kuli Pu’u Street, Kihei, Maui, Hawai‘i, resulting from a water main break.

By correspondence dated March 13, 2023, the Department of the Corporation Counsel provided a copy of the claim.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided an overview of the claim and explained that the parties had reached a negotiated settlement, pending Council approval.

Based on information received and the recommendation of the Department, your Committee voted 8-0 to recommend adoption of Resolution 23-113. Committee Chair U‘u-Hodgins, Vice-Chair Paltin, and members Cook, Johnson, Kama, Lee, Rawlins-Fernandez, and Sinenci voted “aye.” Committee member Sugimura was excused.

WHEREAS, having reviewed the facts and circumstances regarding this matter and being advised of attempts to reach resolution of this claim by way of a negotiated settlement by the Department of the Corporation Counsel, the Council wishes to authorize settlement; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby approves settlement of Claim No. 4076130 in the amount of FOURTEEN THOUSAND NINE-HUNDRED EIGHTY-TWO AND 67/100 DOLLARS (\$14,982.67); and

2. That payment is authorized to satisfy settlement of this claim following the execution of the "Property Damage Release" by Robert Hansen; and


3. That certified copies of this Resolution be transmitted to the Mayor, the Director of Finance, the Department of Water Supply, and the Corporation Counsel.
