The Administration of the Office of Hawaiian Affairs (OHA) will recommend to the Board of Trustees the position of <u>SUPPORT</u> on Resolution 23-194, which proposes the commitment of the Maui County Council to the development of a comprehensive recovery and resiliency plan in response to the catastrophic wildfires of August 2023 in addressing the immediate and long-term needs of residents for recovery and healing, while working toward County disaster resilience.

OHA wishes to express its deepest aloha for the people of Maui, particularly those who have endured loss due to this tragic event. While words may offer limited solace, it is within the collective spirit of resilience that we find hope. In the face of adversity, our communities have shown time and again their remarkable ability to come together, heal, and rebuild. The people of Maui are an exemplary testament to this.

As the principal public agency in the State responsible for the performance, development, and coordination of programs and activities relating to Native Hawaiians¹ and tasked with ever-seeking the betterment of conditions of Native Hawaiians;² OHA provides these insights to bolster the Council's sincere efforts in meaningfully and responsibly addressing Maui's most urgent needs as we collectively move forward.

Ua lehulehu a manomano ka 'ikena a ka Hawai'i (Great and numerous is the knowledge of the Hawaiian people). Native Hawaiian culture is the Indigenous Knowledge of Hawai'i, with a collective trust of scientific research spanning millennia — it is integral to the development of all effective strategies in the State.

In light of the expressed need to consult with relevant experts, OHA takes this opportunity to emphasize the incalculable value of Native Hawaiian voices as an inseparable component of Native Hawaiian Knowledge – voices that have carried geographically rooted traditions across countless generations, often serving as the last bastions of proven knowledge that seamlessly connect our history to the present and maintain the capacity to guide us forward into the far future.

Together, we can envision a future where the timeless resilience of the people of Maui and the wisdom of their ancestors unite to shape a landscape of strength, vibrancy, and sustainability. OHA is dedicated to providing ongoing support, to work alongside the Council and the community to ensure that Maui's recovery encompasses not only the rebuilding and restoration of our shared physical space, but also the revitalization of those intrinsic metaphysical realms³ that underpin the foundation of Native Hawaiian traditions.
