A BILL FOR AN ORDINANCE AMENDING  
THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI,  
OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM,  
GRANTS AND DISBURSEMENTS FOR BUSINESS DEVELOPMENT  
AND TECHNOLOGY, KAHULUI ECONOMIC DEVELOPMENT,  
ENVIRONMENTAL, AND CULTURAL PROGRAMS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended "Fiscal Year 2025 Budget", Section 3.B.12.c.(2).(vii), Office of the Mayor, Economic Development Program, Grants and disbursements for business development and technology, Kahului Economic Development, Environmental, and Cultural Programs, is amended to delete the condition for Brilliant Minds Media Inc. and add new conditional language for Lae'ula O Kai in the amount of \$10,000, Friends of Maui Waena Intermediate School for Falcon Entertainment & Engineering in the amount of \$10,000, and The Maui High School Foundation in the amount of \$5,000, to read as follows:



SECTION 3. This Ordinance takes effect upon approval.


