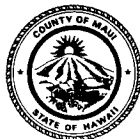

**SUBJECT: MOKU`ULA ISLAND AND MOKUHINIA POND
(LAHAINA) (EAR-43)**

At its meeting of March 1, 2016, the Economic Development, Energy, Agriculture, and Recreation Committee received a presentation from Paul Klieger, Ph.D., the archaeologist who re-discovered Moku`ula Island and Mokuhinia Pond in Lahaina in 1993; and discussed restoration efforts of the site by the nonprofit organization, Friends of Moku`ula, pursuant to a 2003 Lease and License of the County property.

Upon inquiry by the Committee, Dr. Klieger suggested that excavation on the site could start with exposing known segments of the perimeter wall and allowing water to come back to portions of the pond area. He indicated the work could be done in a year.

However, Morgan Davis, the lead archaeologist for State Historic Preservation Division, Department of Land and Natural Resources; and Tanya Lee-Grieg, Director, Cultural Surveys Hawaii, Inc., retained by the County to perform an archaeological inventory survey, discussed the current and potential next stages of the restoration work, indicating excavation could not start until the survey is final.

May I ask you to provide a timeline of expected work on the project, including details of the tasks to be completed and anticipated dates of significant benchmarks?
