SETTING THE ANNUAL SALARY FOR THE EXECUTIVE DIRECTOR OF THE BOARD OF ETHICS UNDER SECTION 2.56.080, MAUI COUNTY CODE

WHEREAS, Section 2.56.080(A), Maui County Code, states: “The annual salary for all board of ethics staff must be set by the council by resolution within the pay range and pay scales established by this section”; and


WHEREAS, Section 2.56.080(B), Maui County Code, states: “The annual salary of the executive director of the board of ethics must not exceed \$227,091”; and

WHEREAS, at its June 18, 2025 meeting, a quorum of the Board of Ethics appointed Lauren Akitake to serve as the Executive Director of the Board of Ethics and set her recommended salary at \$227,091 with a commencement date of August 1, 2025; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That the annual salary for the Executive Director of the Board of Ethics is set at \$227,091, effective August 1, 2025, under section 2.56.080, Maui County Code; and
2. That certified copies of this Resolution be transmitted to the Mayor, Corporation Counsel, Director of Finance and Steven Sturdevant, Chair of the Board of Ethics.

BILL NO. 18 _ (2025)

A BILL FOR AN ORDINANCE ESTABLISHING SECTION 2.56.080, MAUI COUNTY CODE, TO ESTABLISH PAY SCALES FOR THE BOARD OF ETHICS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Title 2, Maui County Code, is to read as follows:

“Section 2.56.080 – Salaries.

A. The annual salary for all staff of the Board of Ethics must be set by resolution within the pay scale established in this Section.

B. The annual salary for the Executive Director of the Board of Ethics must be set within the range for a Bargaining Unit 13 EM-08 between \$110,520.00 and \$157,668.00, but in no case shall exceed the salary of the First Deputy Corporation Counsel.

C. The annual salary for the Investigator must be set within the range for a Bargaining Unit 13, SR-24 as follows:


