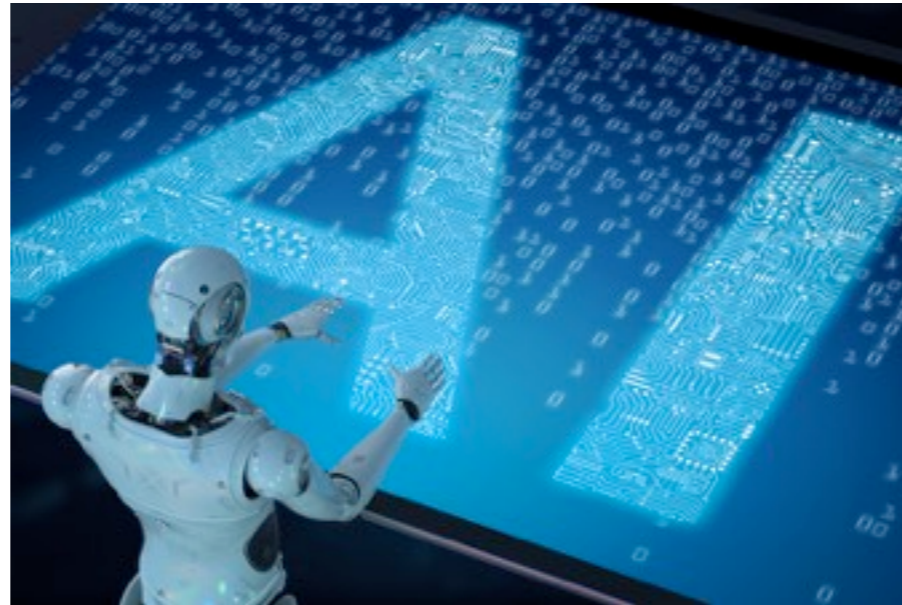
What is 5G?

- 5th Generation
Wireless Infrastructure

5G

- 3G
- 4G (LTE)

Should be called 5G/AI/IoT



What is 5G?

- Adds to - Does Not Replace - 4G (LTE)
- Millimeter wave frequencies 24 GHz+
- Antennas installed every 2-10 homes
- As close as 15 feet to your home
- 40,000+ new satellites low / mid orbit
- Global deployment and pushback
- 2 dozen cities in US

What is 5G?

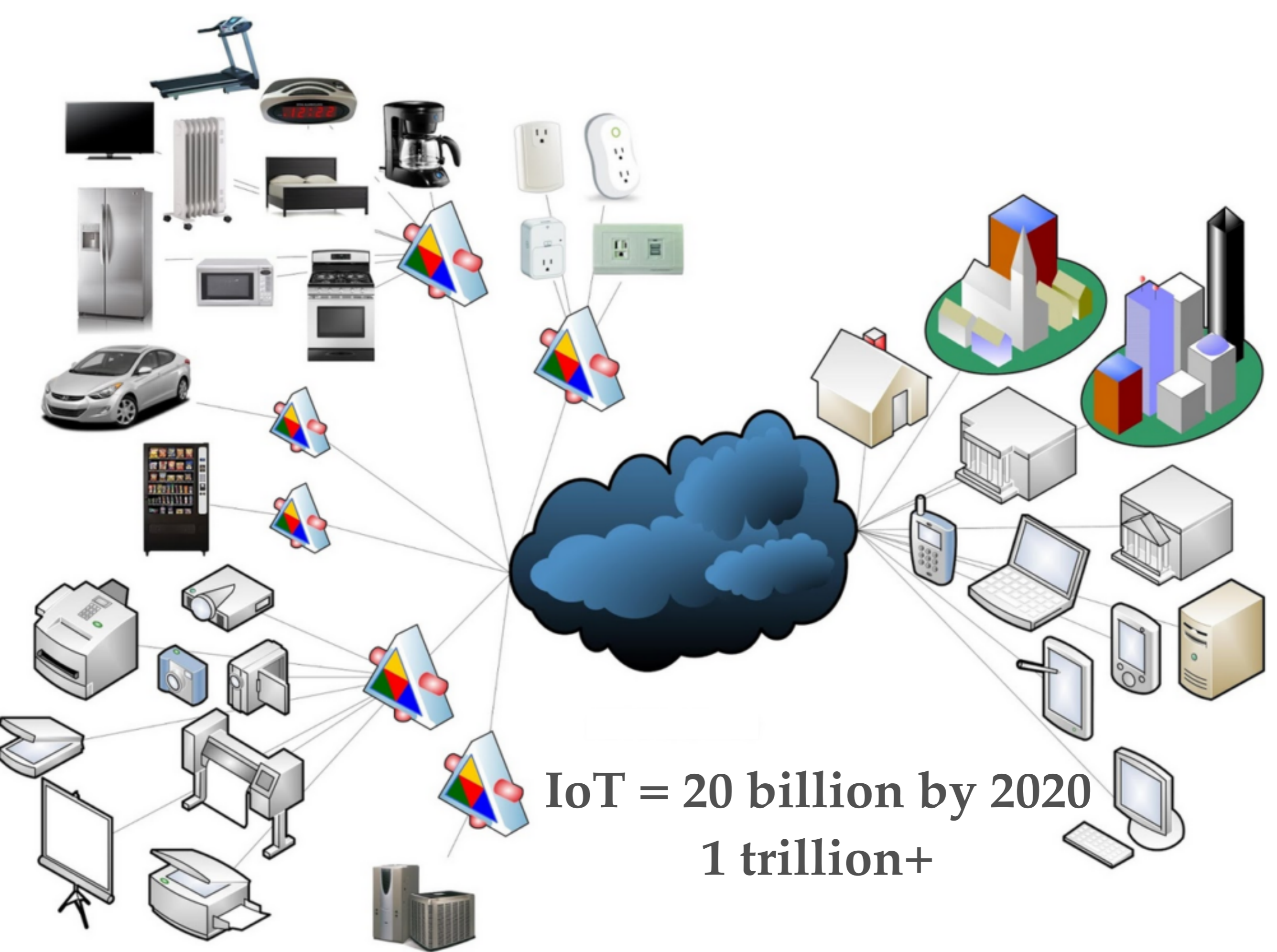
- 5G Base Stations & Devices
 - Multiple antennas in phased arrays
 - Steerable laser-like beams track each other
- Each 5G phone = Mini cell tower
 - Dozens of tiny antennas
 - Track and aim a narrowly focused beam
 - Search and connect to nearest antenna
 - FCC rules - 20 watts, 10x more powerful
 - Radiation ten to hundreds of times greater

- Pour on the propaganda to the public

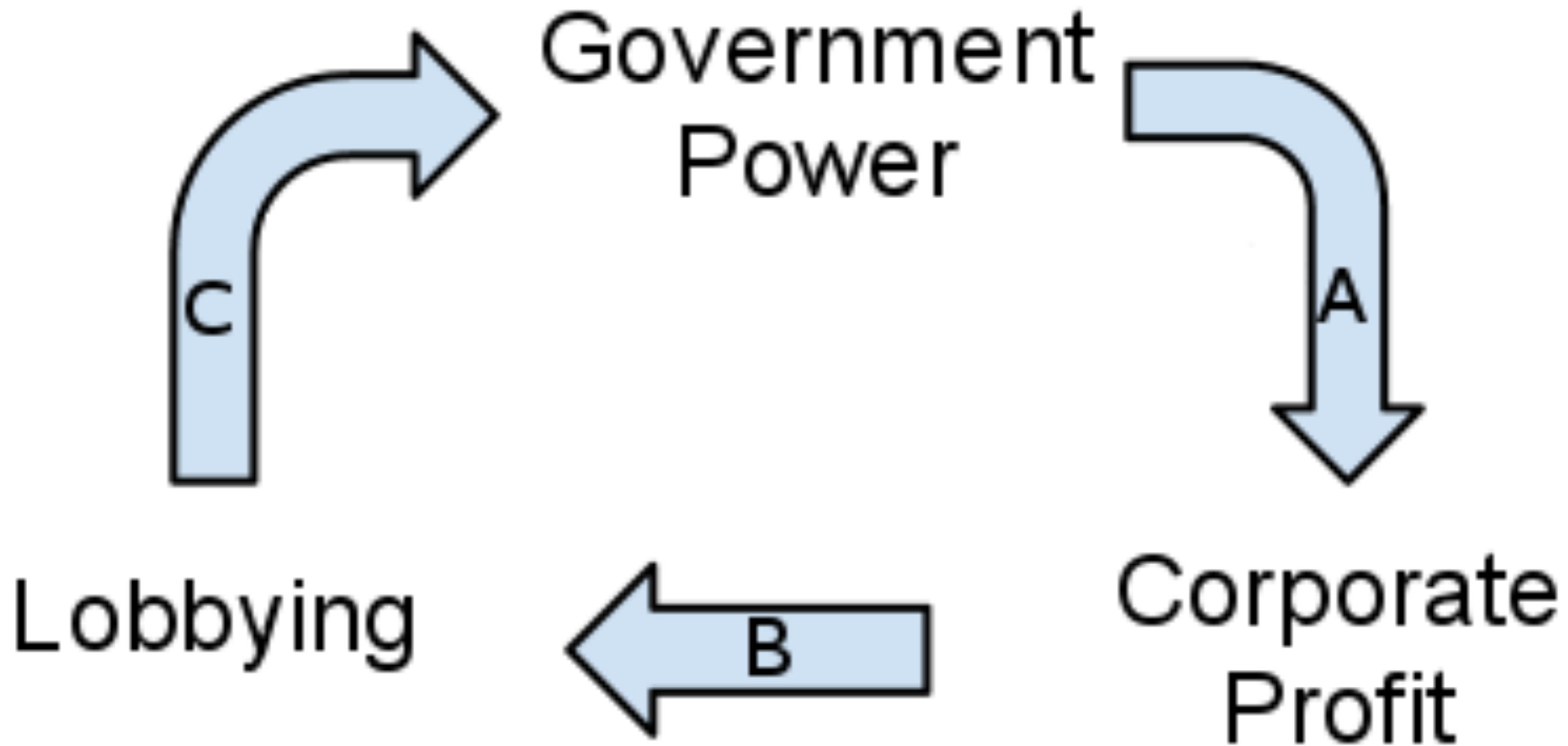

Wireless carriers admit: No scientific studies on safety of 5G and no plans to do any

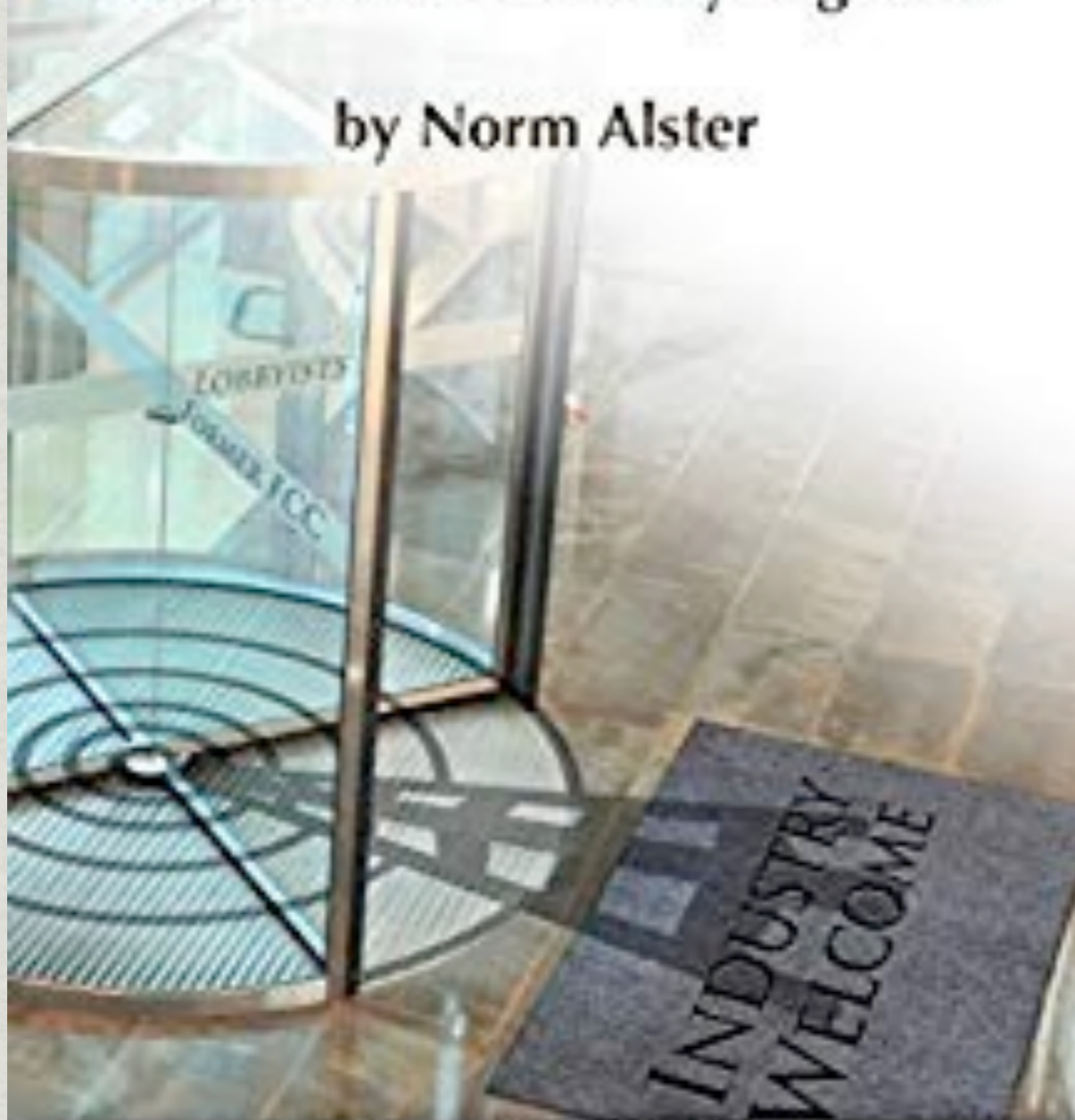
**WHY IS OUR
GOVERNMENT NOT
PROTECTING US?**

- FCC is problematic:
 - Safety limits have not been updated since 1992
 - Based on science from the 1980s
 - US standards among the ***least protective*** in the world
- Telecom Act 1996 Section 704 is problematic:
 - Telecom infrastructure cannot be regulated based on environmental (health) effects

- Problematic Legislation:
- Gov. Ige “5G Rapid Deployment” legislation
June, 2018
- Burt Lum - Counties have final say in 5G
- But restricted...

Sen. Brian Schatz - Pro 5G Bills

S.1699 STREAMLINE Small Cell Deployment Act

- Takes away local authority
- Limits the amount of time to act
- Restricts ways we can act

S.1611 Developing Innovation and Growing the Internet of Things Act

- Identify what inhibits the development or deployment of the Internet of Things
- Encourage and improve what promotes IoT

Pushback

- Senator Dianne Feinstein bill to un-due FCC power grab and restore local authority
- 2 Congressmen formal letter of complaint to FCC Chair Ajit Pai
- Lawsuit against FCC for Constitutional violations
