

#### Overall Sentiment







He is “real”, and I believe he has the knowledge and qualifications to serve on the East Maui Regional Community Board. He has the passion to serve on the board for the right reasons.



MY NAME IS HARRY "AUKAI" HUEU, JR. AND I RESIDE AT 180 WAILUA ROAD, WAILUA/KEANAE.

I'M EMPLOYED FULL-TIME BY THE STATE HIGHWAYS DIVISION KEANAE BASEYARD AS AN EQUIPMENT OPERATOR. I ALSO HAVE A SMALL SCALE FARMING OPERATION CONSISTING OF 20 LO'I KALO. ATTACHED ARE A FEW PHOTOS OF MY TARO PATCHES.

AS A TARO FARMER, HIGHWAYS WORKER, AND EAST MAUI RESIDENT OF 40+ YEARS, I BELIEVE I HAVE THE KNOWLEDGE AND EXPERIENCE TO KNOW HOW TO BETTER MANAGE OUR EAST MAUI WATER RESOURCES. I THINK WATER SHOULD BE ALLOCATED ACCORDING TO THE FOLLOWING PRIORITY USES:

1. MINIMUM STREAM FLOWS FOR HIHIWAI, OPAE, OOPU AND OTHER STREAM LIFE TO NOT JUST SURVIVE BUT THRIVE.
2. LO'I KALO FARMERS.
3. COUNTY OF MAUI SUFFICIENT TO MEET CURRENT RESIDENT NEEDS, ADDITIONAL WATER TO ADDRESS ALL APPLICANTS STILL ON THE UPCOUNTRY WATER METER WAIT LIST AND PROJECTED FUTURE AFFORDABLE HOUSING DEVELOPMENT.
4. EXISTING SMALL FARMS AND RANCHERS.
5. LARGE SCALE AGRICULTURE SUCH AS MAHI PONO, SUBJECT TO DECREASES IN ALLOCATION SHOULD ADDITIONAL WATER BE REQUIRED BY HIGHER PRIORITY USERS. WE NEED LARGE SCALE AGRICULTURE TO ACHIEVE FOOD SECURITY FOR MAUI.

WITH REGARD TO PROJECTS SPECIFIC TO THE KEANAE/WAILUA DISTRICT, COUNTY FUNDING FOR REPAIR/RESTORATION OF LO'I KALO PIPING AND AUWAI DITCH FROM WAIKANE STREAM.

FOR PURPOSES OF TRANSPARENCY, I WOULD LIKE TO DISCLOSE THAT I CURRENTLY LEASE THE OLD EMI KEANAE BASEYARD BUILDING FROM A&B/MAHI PONO. THAT'S WHERE I MAKE MY POI. THE LEASE IS MONTH TO MONTH. I EXPECT MY VIEWS OF PRIORITY USE WILL GET BACK TO MY LANDLORDS. HOPEFULLY, IT WILL NOT RESULT IN POSSIBLE TERMINATION OF MY LEASE. MAHALO FOR GIVING ME AN OPPORTUNITY TO SPEAK.

**Mahalo for your careful consideration.**

During the last WASSP meeting it was obvious that intentional and destructive "politics" were entering into the discussions. For this reason, I am compelled to defend certain actions and recent slanderous attacks on my reputation by a very few self serving community members who think they are "above the law".

Recently, I have been unfairly and illegally attacked by several members of Na Mamo O Mu'olea (NMOM) Board of Directors for strictly following the laws, the NMOM County of Maui Lease Agreement and being a reasonable and responsible founding board member.

These matters involve important water issues including: Protecting the State Registered Historic Mu'olea Spring and distribution system that likely served King David Kalākaua, and Queen Lili'uokalani on Mu'olea Point.

NMOM and the County of Maui have failed to meet the written legal agreements with the National Oceanic & Atmospheric Administration (NOAA) involving the spring and the binding "Public Trust Deed" obligations to Mu'olea Point and the taxpayer public.
