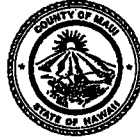

**SUBJECT: ECONOMIC DEVELOPMENT REVOLVING FUND (PEA-36)**

May I please request your response to the following:



3. What is the status of obtaining permits necessary for the project?
4. What is the estimated timeframe for the completion of the project?
