On behalf of the Department of Environmental Management, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI, APPENDIX A, PART I, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, U.S. ENVIRONMENTAL PROTECTION AGENCY - WATER DIVISION, COMMUNITY GRANTS."

The purpose of the proposed bill is to amend the Fiscal Year 2025 Budget, Appendix A, Part I, Grants and Restricted Use Revenues – Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2025, to add a new appropriation under the Department of Environmental

Management, entitled "U.S. Environmental Protection Agency -Water Division, Community Grants" in the amount of \$600,000.

This grant will provide funds for a study related to the construction of a new R-1 recycled water line connecting to the existing distribution system. The line will start at Kihei Research and Technology Park, continue north above Kūlanihāko'i High School, then pass under the Honaapiilani Highway, where it will connect to the existing R-1 recycled water system.
