Chair and Members:

Your Government Relations, Ethics, and Transparency Committee, having met on May 22, 2023, makes reference to Resolution 22-98, entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 4070286 OF DAVID GARDINER."

Resolution 22-98's purpose is to authorize settlement of the claim, filed on May 12, 2021, in the amount of \$68,882.11. The claim alleges damages to the claimant's property located at 36 Kuli Pu'u Street, Kīhei, Maui, Hawai'i, resulting from a water main break.

By correspondence dated March 28, 2022, the Department of the Corporation Counsel requested consideration of Resolution 22-98, with a copy of the claim.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of \$7,500.

A Deputy Corporation Counsel provided an overview of the claim and explained the parties had reached a negotiated settlement, pending Council approval.

Based on information received and the recommendation of the Department, your Committee voted 6-0 to recommend adoption of Resolution 22-98. Committee Chair Uʻu-Hodgins, Vice-Chair Paltin, and members Cook, Kama, Lee, and Sugimura voted "aye." Committee members Johnson, Rawlins-Fernandez, and Sinenci were excused.
