LAHAINA ANTENNA REPLACEMENT;
TOTAL CAPITAL IMPROVEMENTS PROJECT APPROPRIATIONS;
TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), "Fiscal Year 2023 Budget", is hereby amended as it pertains to Section 2, Estimated Revenues, by increasing Bond/Lapsed Bond in the amount of \$3,000,000; and by increasing the Total Estimated Revenues in the amount of \$3,000,000, to read as follows:



1. Section 2, Estimated Revenues, by increasing Bond/Lapsed Bond in the amount of \$3,000,000; and by increasing the Total Estimated Revenues in the amount of \$3,000,000;
2. Section 4.F., Department of Police, by adding West Maui Community Plan Area, Government Facilities, Bond Fund and a project entitled "Lahaina Antenna Replacement" in the amount of \$3,000,000;
3. Total Capital Improvement Project Appropriations to reflect an increase of \$3,000,000; and
4. Total Appropriations (Operating and Capital Improvement Projects) to reflect an increase of \$3,000,000.
