
- *Bridge closed down by county public works **September 24, 2014** to vehicular traffic.

the matter as our East Maui Council Member Robert Carroll had brought forward in his communication 14-308 dated in 2014.

We are hoping at this meeting this item IEM10 will have some sort of positive ACTION taken and clarity to the public and community to be noted and documented by this committee/council on this item and recommendations if any? And to the safety & health concerns, and getting clarity of the position from the administration and county council on the matter so that it is clear and with no misunderstanding to the community of the Yes's / No's or Whys that the County Council/Administration WILL or WILL NOT adopt this bridge and not just have a recommendation to file this communication to have further discussion in next order of business in 2018-2019.
