Aloha Chair Guzman,

As the former Battalion Chief of Ocean Safety for the Department of Fire and Public Safety, I'd like to submit the following written testimony with attachments in support of PRL-45.

Liability concerns has always been a stumbling block when it came to public access rescue tubes (RT) along Hawaii's shoreline. This is why a core group of RT advocates teamed up with Senator Stanley Chang from Oahu who introduced SB 2087 that takes liability away from the good Samaritan who uses the RT and property owner that hosts a RT station on their property. After deliberating in different house and senate committees, SB 2087 was signed into law by Governor Ige on July 06, 2018. Attached is a copy of SB 2087 which amends Hawaii's good Samaritan law. A picture of the signing ceremony in Governor Ige's office is also included. Please note the yellow RT's proudly on display.

One of the great advantages of having RT's available for the public is it allows immediate response by friends or family of victims in distress. Many times these family or friends will not wait till 911 emergency help arrives. Can you stand idly while your loved one cries for help? Many times this results in what we call a "double drowning" where both rescuer and victim succumbs to exhaustion and drown before 911 help arrives. Since 2007 when the first RT was placed on Larsen's Beach on Kauai, there has **NOT** been a double drowning whenever a RT was used. This is due to the fact that RT's **primarily protect the rescuer!** Sometimes the victim manages to make it to shore but the rescuer needs help. Help is already there because the rescuer has the RT to hold onto. This is the reason why double drownings have not occurred while using the RT. Attached is a sad story about two Maui teenagers who died in March 2015 due to the double drowning phenomena. Also included is another heartbreaking story that would have surely been averted had a RT been available.

I would also like to take this opportunity to say RT's do not and cannot replace professionally trained lifeguards. Lifeguards are the communities front line of defense for drowning prevention and most importantly ocean awareness and education. Pu'u Keka'a fronting the Sheraton Maui in Kaanapali desperately needs a lifeguard tower followed closely by the Ukumehame area due to long 911 response times by fire, police, and EMS all located at the Lahaina Civic Center many miles away. Thank you for your consideration to collaborate with the state government who is responsible for **ALL** beaches and near shore waters that county lifeguards protect!

#### A BILL FOR AN ACT

RELATING TO EMERGENCY RESCUE DEVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in Hawaii nearly
- 2 half of all non-resident fatal injuries are caused by drowning,
- 3 and nearly eighty per cent of these drownings occur in the
- 4 ocean. Although lifeguards work tirelessly to protect residents
- 5 and visitors in Hawaii's oceans, many beaches throughout the
- 6 State do not have lifeguards present. Warning signs deter many;
- 7 however, one person each week on average drowns in the ocean in
- 8 Hawaii. The use of rescue equipment makes a rescue safer for
- 9 anyone attempting to assist a drowning victim. The primary
- 10 piece of rescue equipment used by lifequards is the rescue tube.
- 11 The legislature further finds that placement of rescue
- 12 tubes on Kauai, and expanding throughout the State, has led to
- 13 countless rescues of drowning victims. Rescue tubes are easy to
- 14 use for ordinary citizens in rescuing victims and cost effective
- 15 to provide on a widespread basis.
- 16 The purpose of this Act is to provide legal protections
- 17 under the Good Samaritan Law for owners of premises on which
- 18 rescue tubes are located and protections for rescuers who use



- 1 rescue tubes, to guard against liability actions and to
- 2 encourage placement and use of these lifesaving emergency rescue
- 3 devices.
- 4 SECTION 2. Section 663-1.5, Hawaii Revised Statutes, is
- 5 amended to read as follows:
- 6 "§663-1.5 Exception to liability. (a) Any person who in
- 7 good faith renders emergency care, without remuneration or
- 8 expectation of remuneration, at the scene of an accident or
- 9 emergency to a victim of the accident or emergency shall not be
- 10 liable for any civil damages resulting from the person's acts or
- 11 omissions, except for such damages as may result from the
- 12 person's gross negligence or wanton acts or omissions.
- 13 (b) No act or omission of any rescue team or physician
- 14 working in direct communication with a rescue team operating in
- 15 conjunction with a hospital or an authorized emergency vehicle
- 16 of the hospital or the State or county, while attempting to
- 17 resuscitate any person who is in immediate danger of loss of
- 18 life, shall impose any liability upon the rescue team, the
- 19 physicians, or the owners or operators of such hospital or
- 20 authorized emergency vehicle, if good faith is exercised.

- 1 This section shall not relieve the owners or operators of
- 2 the hospital or authorized emergency vehicle of any other duty
- 3 imposed upon them by law for the designation and training of
- 4 members of a rescue team or for any provisions regarding
- 5 maintenance of equipment to be used by the rescue team or any
- 6 damages resulting from gross negligence or wanton acts or
- 7 omissions.
- 8 (c) Any physician or physician assistant licensed to
- 9 practice under the laws of this State or any other state who in
- 10 good faith renders emergency medical care in a hospital to a
- 11 person, who is in immediate danger of loss of life, without
- 12 remuneration or expectation of remuneration, shall not be liable
- 13 for any civil damages, if the physician or physician assistant
- 14 exercises that standard of care expected of similar physicians
- 15 or physician assistants under similar circumstances. Any
- 16 physician who supervises a physician assistant providing
- 17 emergency medical care pursuant to this section shall not be
- 18 required to meet the requirements set forth in chapter 453
- 19 regarding supervising physicians.
- 20 (d) Any person or other entity who as a public service
- 21 publishes written general first aid information dealing with

- 1 emergency first aid treatment, without remuneration or
- 2 expectation of remuneration for providing this public service,
- 3 shall not be liable for any civil damages resulting from the
- 4 written publication of such first aid information except as may
- 5 result from its gross negligence or wanton acts or omissions.
- 6 (e) Any person who in good faith, without remuneration or
- 7 expectation of remuneration, attempts to resuscitate a person in
- 8 immediate danger of loss of life when administering any
- 9 automated external defibrillator, regardless of where the
- 10 automated external defibrillator that is used is located, shall
- 11 not be liable for any civil damages resulting from any act or
- 12 omission except as may result from the person's gross negligence
- 13 or wanton acts or omissions.
- 14 Any person, including an employer, who provides for an
- 15 automated external defibrillator or an automated external
- 16 defibrillator training program shall not be vicariously liable
- 17 for any civil damages resulting from any act or omission of the
- 18 persons or employees who, in good faith and without remuneration
- 19 or the expectation of remuneration, attempt to resuscitate a
- 20 person in immediate danger of loss of life by administering an
- 21 automated external defibrillator, except as may result from a

- 1 person's or employer's gross negligence or wanton acts or
- 2 omissions.
- 3 (f) Any physician or physician assistant who administers
- 4 an automated external defibrillator program without remuneration
- 5 or expectation of remuneration shall not be liable for any civil
- 6 damages resulting from any act or omission involving the use of
- 7 an automated external defibrillator, except as may result from
- 8 the physician's or physician assistant's gross negligence or
- 9 wanton acts or omissions.
- 10 (g) Any person who in good faith, without remuneration or
- 11 expectation of remuneration, attempts to rescue a person in
- 12 immediate danger of loss of life by use of a rescue tube,
- 13 regardless of where the rescue tube that is used is located,
- 14 shall not be liable for any civil damages resulting from any act
- 15 or omission except as may result from the person's gross
- 16 negligence or wanton acts or omissions.
- 17 The owner or operator of any premises, property, or
- 18 facility that is adjacent to navigable waters, where a rescue
- 19 tube is located shall not be liable for any civil damages
- 20 resulting from any act or omission relating to the storage,
- 21 maintenance, or use of the rescue tube.

### Man who died 3/29/18 saving child ID'd

A Montana man who died Tuesday after he jumped into the ocean and saved his daughter was identified as 46-yearold Brian Lazorishak of Whitefish.

Emergency crews were called to Olivine Pools near Kahakuloa at 12:37 p.m.

Fire officials said the man's 15-year-old daughter was standing near the water's edge when a large wave washed her into the ocean. The father jumped in and was able to get her back to the rocky cliff, where bystanders used towels as a makeshift rope to pull the girl up the ledge to safety, officials said.

Lazorishak was seen floating facedown and unresponsive in the water and was pronounced dead at the scene, officials said.

# Families mourn loss of 2 teens

Tabbay, 19, Parilla, 18, remembered as youths full of promise and life

Two promising Maui High School graduates were remembered by friends and family on Tuesday as kind, fun-loving and hardworking.

Emmanuel Tabbay, 19, and Edelene Parilla, 18, were students at University of Hawaii Maui College and forging their career paths when they died in an accident Monday near Honokohau Bay. The two friends were walking near the shoreline to see tide pools

when Parilla was swept away and Tabbay tried to save her.

"It's really a courageous thing what he did — not thinking about himself and jumping in to rescue her," said Tabbay's aunt, Nely Tabbay, in a phone call Tuesday. "Unfortunately, he didn't make it. He was a good person, a good kid and exceeded in high school."

Tabbay, who graduated magna cum laude from Maui High in 2013, was a member of the Hawaii Association of the Family, Career, and Community Leaders of Ameri-

## Woman swept away by wave, man jumps in after her

A man and woman who were found dead in the ocean Monday near Honokohau Bay had been walking near the shoreline to see tide pools when the woman was swept into the ocean by a large wave and the man jumped into the ocean to help her, police said.

They were identified as 18year-old Edelene Parilla and 19year-old Emmanuel Tabbay, both of Kahului.

The two were with two other friends, who were walking with them in an area known as "Chutes and Ladders" when the incident occurred at noon, police said.

One of the friends found a bystander to call for help, police said.

Firefighters responded to the 1:30 p.m. call, meeting with a witness who said both victims went underwater. Two ocean safety rescue skis, two Lahaina crews including a rescue boat and a Kahului rescue crew with the Air One helicopter went to the scene.

ca and earned recognition at the organization's National Leadership Conference in 2012.

He was taking classes at UH-MC's Maui Culinary Academy and working as a line cook at Ruby Tuesday in Kihei. He had previously worked at Roy's in Lahaina and was quickly moving up at his new job, an assistant manager said.

"He was a great worker," Andrew Ellerman said, adding that Tabbay had only worked at Ruby Tuesday for about a month. "I didn't know him as well as I wish I could have, but he was very promising and I saw a lot of amazing qualities in him. We were looking to move him up and forward."

Parilla, an honor roll student and 2014 Maui High grad, also was attending UH-MC and had dreams of becoming a pilot, a family friend said.

Lawrence Pascua mentored Parilla and Tabbay in his Filipino folk dance group La Galeria for four years. He said the two teens were close and that Parilla was one of the few girls who could execute tinikling, the tricky traditional dance.

"She was a really good dancer," Pascua said. "She also was a prankster and really loved playing jokes. She was a happy person, very ambitious in whatever she did.

"Everybody loved her because she was very nonjudgmental, so kids opened up to her and they would go to her and talk to her because she was very approachable."

Rescue divers did an underwater search and found the man and woman submerged near the point where they had been last seen, said acting Fire Services Officer Edward Taomoto.

Police said the victims had no signs of life and were pronounced dead at the scene.

Autopsies are pending.

The National Weather Service had issued a high-surf advisory for north-facing shores of Maui through Monday evening.

Firefighters responded to two other cases of people pulled

from the ocean Monday afternoon.

At 3:08 p.m., a 53-year-old Spokane, Wash., man was pulled from the ocean at South Maluaka Beach Park fronting the Makena Beach & Golf Resort after he was seen floating lifeless, Taomoto said. He said a visiting firefighter from the Mainland performed CPR until Wailea firefighters arrived. Police, then firefighters and medics were unable to revive the man, who had been snorkeling with his wife.

He was pronounced dead at the scene. He was identified

as Larry Robins. An autopsy is pending.

About a half-hour later, at 3:32 p.m., bystanders pulled to shore a man who was seen floating facedown in the ocean fronting the Kaanapali Ocean Resort, Taomoto said. He said firefighters and paramedics performed lifesaving measures before the man was transported in critical condition to Maui Memorial Medical Center. The man, whose age wasn't available, is visiting from Colts Neck, N.J.

With Lahaina and Napili firefighters on scene near Honokohau Bay, firefighters from Kahului and Kihei were in the

district to respond in Kaanapali.

Facebook posts and photos of the two have also overflowed online, with many friends changing their profile pictures to a photo of Tabbay and Parilla posing together.

"I give him credit. He was working and going to school at the same time and hardly has any time off," Nely Tabbay said. "For a kid, that's an accomplishment on his part because not too many kids can do that. He's a great loss, and the parents especially were devastated for this all.

"It's hard for them to ab-

Tabbay's death was equally

difficult for his 14- and 15year-old cousins Kimberly Nicole Calinog and Rhealynne Tabbay. The cousins are freshmen at Maui High School.

"He was kind, generous; he was loving, he was joyful, and he was the best guy," Rhealynne said.

"He's really friendly; the type of friend that would always be there and whenever you're sad he'd take you out and cheer you up," Nicole said.

Tabbay was born in the Philippines and moved to Maui in 2010 with his mother and sister. Rhealynne grew up with Tabbay in his native country

and later moved here.

"He would always be the one to take care of us," she said. "I remember how we used to play before . . . and we used to go to the same school. He would always make friends. He was a good person."

The two cousins recalled a trip in January, when Tabbay drove them and two others to the pool, followed by treating them to pizza and ice cream. They finished the day watching the sunset from Front Street.

Nicole said that when she found out about her cousin's death her "body just shut down.

"My mind went completely blank. I felt so lifeless," she said.

Parilla's family asked for privacy. Pascua said she is the only girl in her family among several boys. Her youngest brother is a sophomore at Maui High and the two would "play pranks on each other all the time," he said.

"She was a very fun-loving person," he said. "She loved going places and was adventurous. She liked discovering new places on Maui."

Pascua said Parilla was an "excellent artist" and loved drawing. He said she did her senior project on art and was taking art classes in college.

Pascua added that she deeply loved her family and cared for her brother's fiancee when she gave birth. Parilla stayed with the woman during her whole pregnancy and would regularly babysit.

"I know Edelene was on her way to become who she was going to be," Pascua said.
