SANDHILLS ESTATES SUBDIVISION

Transmitted herewith is draft RESOLUTION APPROVING DISPOSITION OF NONEXCLUSIVE
WATERLINE EASEMENT DUE TO RELOCATION OF WATERLINE IMPROVEMENTS IN THE
SANDHILLS ESTATES SUBDIVISION.

The purpose of the existing easement was so that the County of Maui Department of Water Supply had a right and easement to construct, install, maintain, operate, repair, remove, replace, and reinstall waterlines. The Sandhills Estates Subdivision constructed waterlines that were installed in the roadways rather than within the developable lots of the subdivision. Therefore, the County of Maui does not anticipate installation of the waterline in the existing easement and is requesting approval to cancel the easement. Pursuant to Section 3.44.010, Maui County Code, this is considered a disposition of real property, which requires the authorization of the Council by resolution.
