A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM, NEW CONDITIONAL LANGUAGE FOR PROARTS, INC. IN THE AMOUNT OF \$49,570

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5816, as amended, "Fiscal Year 2026 Budget," Section 3.B.12.c.(2).(xxv), Office of the Mayor, Economic Development Program, Grants and disbursements for business development and technology, South Maui Economic Development, Environmental, and Cultural Programs, is amended to add conditional language for ProArts, Inc. in the amount of \$49,570, to read as follows:

<u>(d) Up to \$49,570 must be for                     ProArts, Inc. for Pono Project.</u>


