ACTING ON THE NOMINATIONS OF CAYLA RAE KUTAKA AND CATHERINE MOMI MEDEIROS TO THE COMMISSION ON CHILDREN AND YOUTH

WHEREAS, the Commission on Children and Youth was formed and operates with nine members under Section 2.39.010, Maui County Code; and

WHEREAS, two vacancies will occur on the Commission on Children when existing terms expire on March 31, 2026; and

WHEREAS, by correspondence dated January 29, 2026, Mayor Richard T. Bissen, Jr. notified the Council he nominated Cayla Rae Kutaka and Catherine Momi Medeiros listed in Exhibit "A," as attached, to fill the vacancies; and

WHEREAS, the nominations are made in accordance with Section 2.39.010, Maui County Code, and Sections 13-2, Revised Charter of the County of Maui (1983), as amended; and

WHEREAS, Charter Section 13-2(17) requires the Council to approve or disapprove the Mayor's nomination within 30 days after the Mayor submits the name of the nominee to the Council and, if the Council disapproves the nominee, to immediately notify the Mayor and the Independent Nomination Board of the Council's action; now therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of the persons listed in Exhibit "B," as attached, as members to the Commission on Children and Youth for the term expiring on March 31, 2031;
2. That it hereby disapproves the appointment of the persons listed in Exhibit "C," as attached, as members to the Commission on Children and Youth as nominated by the Mayor;
3. That the Council expresses its gratitude and appreciation to the nominees for their willingness to be considered for public service and actively participate in County government; and


