

Overall Sentiment









The Program hires community vendors to provide haircuts, lomilomi, podiatry (foot doctor) visits, house and yard cleaning services, and most recently, they are providing computer classes to whomever is interested in learning to use the computer. The Program has also provided various educational sessions for the Kupuna, for instance, Medicare and Social Security changes and/or support; Dementia and, Support Group for Kupuna Caregivers. All of the services are Program driven and "free". The response has been so positive among the Kupuna. They have said "without this Program I would never have gotten my hair done, or have a wonderful lomilomi......I feel like a new person!" "I haven't been able to clean my

house or my yard for a very long time and having people come in and provide such a service is so appreciated; it makes me smile and I feel good when my yard and house is clean". Although these services are free, the Kupuna provide a tip to those that provide the services, and, the Kupuna can hire the providers on their own. It provides continuous employment for all those providers, also.

As a Kupuna, I have taken advantage of the Kupuna Care Program also. It was very uplifting to have a hair cut and lomilomi at my fingertips! I felt like a new person. I have hired one of the lomilomi providers. Please pass this bill. Mahalo.

My name is Chantelle Brown and I would like to submit testimony on having lifeguard services at Pu'u Keka'a.

I would like to start off by stating that although we all know that Pu'u Keka'a definitely needs ocean safety officers posted.... This expansion of our bureau needs to be built right starting with its core structure. What I mean is that the funding should be all in place and ready to roll from the State covering every piece of equipment, materials, manpower, etc. needed to run efficiently.

Pu'u Keka'a should mirror the operations of Big Beach, Makena being that they are both state. Pu'u Keka'a should have lifeguard services because:

- 1. The only time I've saw this beach empty is when travel was at a halt due to Covid-19. Other than that, this location is covered with visitors from sunrise to sunset and increases every single year
- 2. Being that the tourism is booming in the West District, in particular Pu'u Keka'a... there are hundreds of incidents that happen every year whether it be assists, minor first aids, major first aids, 911 emergency calls, cpr, missing persons, etc
- 3. In relation with reason #2, the medical and emergency response to this area with ocean safety officers would be on point and in seconds which equals saving lives

The Bailey House Museum represents a unique part of the history of our Island and State. Now known as Hale Ho'ike'ike at the Bailey House, this parcel of land at the perimeter of the Wailuku business district, stands as a testament of the good element of the Missionary migration. Not all members of the Missionary community profited from large land acquisition occurring in the 1800s.

Under Edward Bailey's direction, the Bailey House became a women's school of education. Well before Congresswoman, Patsy Mink co-created Title IX in 1972 offering no gender discrimination when it came to education, The Bailey House provided the young women on Maui that education.

Being one of the first "Western styled" houses on the island, it has been preserved to include artifacts and relic, not found in the more well known Bishop Museum on the Island of Oahu. The grounds, with the lush tropical vegetation of Iao Valley maintained by volunteers, offer the outdoor lifestyle of yesteryear.

Artifacts in the museum include both Western and Hawaiian cultures. The small acreage of Hale Ho'ike'ike contributes and provides intimate venues of music, hula, and dance for island residents and visitors alike. These gatherings, small in nature, have no traffic impact on the Wailuku community like an event at the Maui Arts and Cultural Center.

Aloha council members. Having now lived here since 2013 I can't help but take an interest in a couple of Maui situations that I think can be better addressed in the budget.

• Real Property Taxes on 2nd homes. Living on the west side makes it easy to see the unusually large number of vacant second homes while at the same time we bemoan the lack of affordable housing for our residents. The mismatch between the community's needs in housing and the consequences of a poorly utilized housing stock is stark. Council has taken significant first steps to rectify this imbalance by creating new tax tiers and introducing the long term rental credit. But these measures will do little to redirect more of the existing idle housing for the benefit of our residents.

I suggest Council raise the tax rates on non-owner occupied investment homes dramatically. By this I mean at least 50% to as high as 100%.

UHERO and others have made clear offshore demand contributes to outsized price increases. Council can do little to control mortgage interest rates and global economic conditions that lead to rapid price appreciation. But it can significantly influence the total cost of ownership effecting the profits offshore investors expect when choosing where to purchase an investment.

Advantages of reducing the number of offshore investment owners on Maui:

- Increasing the carrying cost of investment property through taxes make it less attractive
 to offshore investors. When our tax rate is too low we are effectively subsidizing
 investors who purchase here at the expense of local families.
- Increasing rates can reduce extreme price swings by discouraging a fickle source of
 incremental demand encouraged by local tax rates. Local ownership provides a more
 reliable tax base that doesn't cut and run when the cycle turns against real estate. This
 will also smooth the growth in assessments to more sustainable level while mitigating
 the worst effects of distorted price movements.
- Discouraging offshore buyers with tax rates reduces excessive price appreciation
 penalties on existing homeowners. Price appreciation is great when you sell but while
 you actually live here you pay an annual penalty through increased taxes, insurance,
 repair costs and more.

Maui has many qualities that make it an extremely desirable place to live. Just as tax rates for the visitor industry reflect these qualities, so should tax rates for off shore home ownership. In many ways investor ownership is a form of 'visiting' as these purchases become incremental demand on the upside and incremental sales on the downside. Using mainland averages as a

fairness gauge for determining the appropriate tax rate values our island far short of its true value. Raising rates on this class of property will reestablish fairness between real estate investment property and real estate owned for local residential needs.

• The increase should be significant to quickly offset the effect of potentially lower assessments in the short term caused by tax motivated selling in this category.

The Real Estate Industry will oppose anything that threatens prices.

- Real estate people may argue that you will 'kill the golden goose' of high prices with unfair tax rates. But if any particular area is experiencing outsized investment its because investors expect an 'alpha' return compared to those available in competing opportunities. There is no unfairness in extracting tax value from these investments.
 The unfairness occurs when low taxes encourage these investments.
- Real estate people will say higher prices for locals are the price to be paid for an eventual higher selling price but prices on the day you need to sell are determined by the economic conditions of the moment. People using their properties as homes don't have the luxury to 'play the cycle' like investors do to sell high or buy low. On the other hand, sustainable price appreciation built on solid fundamentals such as equitable taxes will result in more sustainable if not so dramatic appreciation.
- Real estate people will say we should build our way out of this. Its true we have to build new housing to redress the imbalance created by too low tax rates. But every existing home that is sitting idle for most of the year (and sometimes longer) is an opportunity for a local buyer if the current subsidy provided by too low rates is redressed. I don't expect a majority or even a large number of unoccupied homes will be put up for sale but we should encourage market behavior that is fair to local residents and taxpayers competing with offshore buyers.

Bottom line, I respectfully request you consider raising investment home real property tax rates a priority. While there are fundamental reasons that housing here is more expensive than the mainland I believe current tax policy is contributing to a situation that promotes the growth of idle housing stock while denying the local population the advantages higher tax revenues can bring to their daily quality of life while burdening them with a higher costs of ownership.

- Raise the property tax rate on short term rentals to that of timeshares. This was suggested to Council during a recent presentation and seems quite sensible. I believe the low tax rate coupled with the inability to identify and enforce the rate on short term rentals contributes to unnecessary home price escalation. Along with many others, I am concerned that too many find it easy to engage in short term vacation renting as a completely tax free activity. I would prefer we do away with vacation rental permits entirely and return to the designated areas of Kapalua and others as the only vacation rental venues. But I realize this would not be easy to legislate so if we can achieve a similar result by taxing and enforcement then I would like to see us do so.
- Animal Management The Maui Humane Society Feral animal control. Stray and feral cats have been a large island problem for a long time. There are many reasons why this situation continues from a lack of natural enemies to literally no regulation of free roaming cats. The

Humane Society, tasked with managing animal control, is wed to the Trap Neuter Return policy advocated by most humane organizations. While I understand its appeal in that TNR places the priority on the humane treatment of cats, it creates its own set of problems.

It fails to address the problems of an existing over population. MHS would likely say there are 40,000 feral cats on Maui. I suspect this might be a low number. Many of us are well aware of cat feeding areas, some on County property, where colonies are routinely fed and protected. The number of cats that appear at feeding time is astounding. And its common to see food tins and plastic watering bowls in parking lots, along the beachwalk at waters edge, and even golf courses and hotel properties. Along with anyone who regularly travels from the West side to Kahului and back, the number of times I make that trip without seeing at least one dead cat carcass in the highway is the minority of times. 40,000 is a big number but if anything, I think its low. And most neighborhoods have residents who seem convinced they have a right to use their neighbors property and any empty lot as a litter box because there is no county or state law saying they have any responsibility regarding pet waste. This creates some very disgusting conditions.

TNR also fails to address what an introduced species of one of nature's best natural killers does to an island ecology with no natural defense of competing predators or harsh weather. Hawaii has one of the highest number of extinct species on the planet and yet we allow cats to roam without restraint. In fact, we allow hotels and time shares at waters edge to house stray cats for the enjoyment of guests even though we suspect their waste contains a toxin harmful to certain whales. Quite an example of where we choose tourism over native species. Between bad choices and climate change effects on habitat and insect spread we will no doubt continue to receive this extinction distinction.

I don't think the solution is to abandon TNR and revert to ham fisted culling of the population.

But one improvement we can make is to *impose an annual requirement on MHS for proof of population reduction* towards an aggressive goal that actually brings the cat population under control. *Proof would be tied to funding.* No population reduction results in a risk of funding reduction. On the other hand, verifiable meaningful reduction should be rewarded.

MHS will struggle with this. To maintain support for funding they will want to avoid confrontation with aggressive and vocal cat advocacy groups. I also have personal experience with one MHS Board Member on this topic that is anything but open minded. But short of legislating the behavior of cat owners I think we have to try it. If we don't do something we may soon have an ecology of only cats, myna birds and mongoose. And if we find MHS is not willing to make this change due to a lack of organizational will then we should move this to an entity unencumbered by conflicting goals.

Maui Economic Opportunity, Inc. (MEO) County of Maui Funding Requests for FY 2023

MEO BDC- requesting a 2.6% (\$5,880) funding increase for <u>a total of \$290,800.00</u> to cover an increase operating expenses.

Ag Grant- we also <u>requested \$1.5 million</u> to support another round of Ag Grants. The current funded level is \$1.5 million which assisted 59 farmers. We received 300 applications.

It is my understanding that the Mayor's budget has allocated \$2.5 million to support another round of Aq Grants. If approved, we suggest that MEO be allowed to assist those farmers who qualified, but were not funded during this fiscal year. In the 2021 fiscal year, MEO received \$2.5 million and assisted 103 farmers.

Being Empowered and Safe Together (BEST) Reintegration Program - requesting a 58% increase of \$62,715 to add one additional case manager for a total of 2.5 FTEs and cover an increase in operating expenses. <u>Total request is \$170,865.00</u>.

Enlace Hispano- requesting a 17.3% (\$18,203) increase to upgrade the 25 hour part-time position to a 40 hour fulltime position for a total of 2.0 FTE and cover an increase in operating expenses. <u>Total request is \$123,450.00.</u>

Head Start After School- requesting an additional \$8,105 (3%) increase to cover an increase in operating expenses. <u>Total request is \$278,265.00.</u>

Head Start Summer- requesting a 3% (\$5,678) increase to cover an increase in operating expenses. <u>Total request is \$19,940.00.</u>

Kahi Kamali'i (Infant Toddler Center) – requesting a 3% (\$3,237) increase to cover an increase in operating expenses. <u>Total request is \$111,122.00.</u>

Maui Independent Living Center (MILC)- requesting a 2.5% (\$1,550) increase to cover an increase in operating expenses. <u>Total request is \$64,750.00.</u>

Planning & Coordinating Council- requesting a \$2,390 (2.4%) increase to cover an increase in operating expenses. <u>Total request is \$89,465.00.</u>

Underage Drinking Prevention- requesting a 2.5% (\$1,345) increase to cover an increase in operating expenses. <u>Total request is \$55,170.00.</u>

Aloha mai, e ko ka 'Aha Kūkā o ke Kalana 'o Maui,

We are the Membership of Huamakahikina, a coalition of Kumu Hula, open to all Kumu Hula and representing the breadth of Hula Lineages, standing together for the purpose of organizing and advocating on behalf of Kumu Hula and the 'oihana of Hula itself. Huamakahikina formed and ratified the "Huamakahikina Declaration on the Integrity, Stewardship, and Protection of Hula" on August 21-22, 2021, at the Kupukalālā Kumu Hula Convention, which brought together 200 lineally acknowledged Kumu Hula from across the Pae'āina o Hawai'i, 10 states of the United States of America, and the countries of Japan, New Zealand, French Polynesia, France, and Spain.

The Maui County Council was the first in the state to adopt the Huamakahikina Declaration through resolution CC 21-484, in November, 2021. On page 3 of the Huamakahikina Declaration, the 200 ratifiers acknowledge the historic challenges to Hula, amongst them is:

5. ACCESS & RESOURCING. There are challenges to engaging in the study and practice of Hula for a significant portion of the people of Hawai'i, most importantly Kānaka Maoli, due to a scarcity of resources and significant gaps and disparities in how Hula is recognized, treated, provisioned, housed, funded, and otherwise supported by local County and State governments. The result is that Hula is too often financially and/or geographically inaccessible.

On April 5, 2022, the recommendation was adopted for SCR121/SR108 "URGING THE COUNTIES AND THE STATE TO WORK WITH HUAMAKAHIKINA AND KUMU HULA TO ESTABLISH POLICIES PROTECTING HULA" (included).

BE IT RESOLVED by the Senate of the Thirty-first Legislature of the State of Hawaii, Regular Session of 2022, the House of Representatives concurring, that the counties and state government of Hawaii are urged to work closely with Huamakahikina and Kumu Hula to rectify the above problems through the establishment of new policies and increased resources including public funding and facilities to ensure that hula flourishes for generations to come . . .

As experts in traditional knowledge and leaders of our communities, Kumu Hula uphold and instill the importance of environmental stewardship; we educate 'ohana from keiki to kūpuna; we tell and celebrate the stories of our home, and sing of its beauty; and, the Kumu Hula and Hālau Hula of Maui County bring both joy and pride to its people.

Unique lineally-passed histories, techniques, and knowledge not found in conventional school systems, libraries, or other mainestream resources are only available through practitioners of Hula and 'Ōiwi arts. As a constitutionally protected traditional and customary practice (ARTICLE XII, SECTION 7), Hula is not only integral to Kānaka Maoli, but to the local culture, identity, and



economic sustainability of Maui County. And, although Hula and 'Ōiwi arts are tangible and intangible cultural heritages of Kānaka Maoli, they are nondiscriminatory in that these traditions and knowledge are available to *all* who would dedicate themselves to them.

As has always been the case, and more urgently with knowledge that more than half of all Maui residents were born out-of-state, the practices of Hula and 'Ōiwi arts are extremely crucial for the maintainance of the unique identity and collective culture of the people of Maui County – most importantly to instill these practices and values within the future generations to come. The Hālau of 'Ōiwi Art will not only serve as a necessary bastion for the practices of Hula and 'Ōiwi arts, but it will also serve to show just how committed the Maui County Council is to the protection and continuation of the unique identity, cultural wellbeing, and economic sustainability of the people of Maui County. An investment in the Hālau of 'Ōiwi Art truly is an investment in the community that will bring lasting benefits into the future.

We, the people of Maui County, <u>mindful of our Hawaiian history</u>, <u>heritage and culture and our uniqueness</u> as a four island county, dedicate our efforts to fulfill the philosophy decreed by the Hawaii State motto, "Ua mau ke ea o ka aina i ka pono." - ¶1, PREAMBLE "CHARTER OF THE COUNTY OF MAUI"

Through consensus and without reservation, and as is consistent with the "HO'ĀLA: CALL TO ACTION" of the Huamakahikina Declaration, the Membership of Huamakahikina humbly requests that the Maui County Council funds the Hālau of 'Ōiwi Art to the fullest extent possible.

BENEFICIAL NATURES OF HULA & 'ŌIWI ARTS

ECONOMY

Hula events and pursuits are important and consistent contributors to Maui County's economy. At any given Hula presentation, a good number of spectators are family members and friends of at least one of the performers. Whether it is a performance for "First Friday," for a Hula competition, or any other type of Hula event, these are the people buying the bulk of the tickets, purchasing from concession stands and vendors, eating in nearby restaurants, shopping at nearby stores and markets, buying lei, ordering from florists, employing hair and makeup stylists, hiring photographers, purchasing apparel from local designers, buying from Hula supply businesses, buying from craft stores, purchasing from fabric stores, employing silk-screeners and printers, hiring seamstresses and tailors, and even supporting local farmers (of things like foliage, flowers, ipu, and foods). If people come from out-of-county, -state, or -country for such events, they are also the ones buying airline tickets, renting cars and accommodations, refilling their gas tanks, hiring on-island caterers, and spending money across Maui County at numerous other sites and businesses. Additionally, Hula practitioners are professionally employed at shows and venues across Maui County.

INFLUENCE ON THE UNIQUE CULTURE OF MAUI COUNTY

At any given public Hula or local culture event, many other 'Ōiwi arts are also present. At performances of either Hawaiian or local music, lei, aloha attire, 'ukulele, and even vocal and instrumental techniques are firmly rooted in 'Ōiwi arts. Many Hawaiian music entertainers reflect a distinctly Hawaiian set of presentation qualities and techniques that stem from lines of monarchy/court presenters, from the heyday of Hula's hapa-haole entertainment times, or from both. If the master-of-ceremonies of these events is from a Hawaiian/local music radio station, then they, too, are directly tied to the 'Ōiwi art of Mele. Hawaiian/local music musicians, vocalists, and entertainers are also professionally employed at shows and venues across Maui County. Additionally, when Hawaiian or local foods are served at local events, they are extensions of 'Ōiwi and local culinary arts, as well as the traditional 'Ōiwi arts of cultivation, harvesting, and gathering techniques used to procure and prepare ingredients that range from fish and limu, to kalo, sweet potato, breadfruit, pohole, 'ōpae, pork, even beef liver, and the list goes on.

DEEP VALUE OF HULA & 'ŌIWI ARTS

Knowledge of 'Ōiwi arts currently being revived on a wide scale was also stewarded under the auspices of Hula during the years of their dormancy, such as the tradition-based practices of: Chant, prayer, oratory arts, language arts, Mele composition, singing styles and techniques, vocal- and music-arranging, various forms of protocols, blessings, 'awa ceremony, food preparation, healing and medicinal practices, mediation, kōkō net making, kapa making, lau hala weaving, fiber arts, feather-working, motifs used in graphic design and tattooing, carving, lashing, manufacture of traditional attire and adornments, astronomy, meteorology, oceanography, toponymy, geology, geography, hydrology, architecture, biology, botany, navigation, farming, fishing, animal husbandry, fishpond revitalization and management, Makahiki ceremonies and games, environmental stewardship, species conservation and preservation, and truly countless others.



HIGHLY VALUED CULTURE & KNOWLEDGE

Distinct Hawaiian/local forms of social interaction, values, self discipline, and expectations are actively practiced and conveyed intergenerationally by practitioners of Hula and 'Ōiwi arts. Distinctly Hawaiian methodologies for the processing and interpretation of data found within mele and mo'olelo are only accessible through lineally-descended practitioners. Hula and 'Ōiwi art practitioners are consistently sought and consulted by various County and State agencies, as well as by scientists, archaeologists, anthropologists, and other western culture-based studies experts, for our unique tradition- and lineage-based knowledge and expertise. Practitioners of Hula and 'Ōiwi arts also incorporate our lineage-based knowledge and values into our homelives, our work-lives, our social-lives, our religious-lives, and into our political-lives, as well.

SENATE CONCURRENT RESOLUTION

WHEREAS, Huamakahikina first convened on August 17, 2020, to amplify the voices of Kumu Hula, or those recognized to represent the hula lineages and advocate for the proper preservation of this art form; and

WHEREAS, growing interest in Hawaiian culture, especially from popular media, has led to misrepresentation, cultural misappropriation, exploitation, and abuse of hula through those who would teach hula without being acknowledged Kumu Hula; and

WHEREAS, the spread of incorrect choreography, designs, proper names, and lexicons weaken the standards and expectations for hula and both damage its reputation culturally and economically, as well as perpetuating ignorance; and

WHEREAS, there is insufficient protection for intellectual property rights for which Kuma Hula are entitled; and

WHEREAS, there is insufficient acknowledgement of the rigorous training Kumu Hula undergo regarding how they are valued in the professional labor market; and

WHEREAS, there is insufficient resources in place to rectify the problems stated above, due to a scarcity of resources provided by the county and state government and significant disparity in how hula is recognized, treated, and housed; now, therefore,

BE IT RESOLVED by the Senate of the Thirty-first
Legislature of the State of Hawaii, Regular Session of 2022, the
House of Representatives concurring, that the counties and state
government of Hawaii are urged to work closely with

resources including public funding and facilities to ensure that
hula flourishes for generations to come; and

Dear Chairperson Lee and Council Members:

Thank you for giving me the opportunity to testify today on behalf of Hawaii Animal Rescue Foundation's Multi-Use Barn Project. My name is Dawn Pfendler, and I am the Chief Executive Officer and Co-Founder for Hawaii Animal Rescue Foundation aka HARF.

HARF was established in 2011 with its primary focus on pet adoption and humane education. Over the years our scope of work expanded to include partnerships with animal welfare organizations statewide, the Department of Education and numerous youth-at-risk organizations, such as, the Friends of the Children's Justice Center of Maui and the Second Circuit Courts. We also provide no/cost and low/cost spay and neuter services to the community and we are currently the only organization on island rescuing and rehabilitating livestock in need.

I. **Project Information:**

Request from County of Maui

Hawaii Animal Rescue Foundation (HARF) requests monetary support of \$250,000 towards the completion of their "shovel ready" Multi-Use Barn.

Project Location

Construction of the Multi-Use Barn is on HARF's property located at: 1715 Kahekili Highway, Wailuku, HI 96793. TMK (2)3-2-009-003. HARF purchased the property in April of 2017 for \$800,000. There is a privately held mortgage against the property in the amount of \$700,000.

How Project Supports Agency's Mission and Goals

HARF's mission is to end animal abuse, neglect and homelessness on the island of Maui, strengthen the human animal bond and create a place where people help animals and animals help people.

HARF's programs have been bursting at the seams for years. From its inception, HARF planned to have a physical animal shelter, as its current "shelter without walls" limits the number of animals they can save and the number of people they can serve. HARF calls the future facility a "Center" where they can bring animals, people, and nature together for the benefit of all three. In 2017, HARF's dream came to fruition with the purchase of ten (10) acres of land in Waihee, Maui

The Multi-Use Barn project supports the agency's mission and goals in numerous ways:

- It allows for HARF to transition from a "shelter-without-walls" to a physical bricks and
 mortar agency. The Multi-Use Barn project is phase I of HARF's overall plan to build a
 Community Education and Animal Center on HARF's 10-acre property. Upon completion
 of the barn, HARF will move operations to the barn, thereby finally having a consolidated
 physical location in the community.
- The Multi-Use Barn will increase HARF's animal life-saving capacity by an estimated 70% from its current foster-based numbers.
- It will increase volunteer opportunities, allowing the agency to expand programs, such as, school required volunteer programs, court appointed community service, intern and training programs for youth and countless other opportunities
- Completion of the Multi-Use Barn will allow for "on site" Humane Education programs for Maui's youth with the addition of kid's camps, after school programs and mentorship opportunities.
- A bricks and mortar space will allow for increased productivity of the agency as a whole and eliminated current lease and out-sourced dog boarding expenses.

II. <u>Business Plan:</u>

Organization:

HARF was formed in 2011, to combat the high kill rate of dogs at the municipal shelter on Maui. Over 1,500 dogs were being put to death each year, and HARF knew they could make a difference. The team decided to "do whatever they could" with the few resources they had, which was to

pull as many dogs out of the shelter as possible, build a network of volunteers to foster the dogs, and hold adoption events every weekend at a highly visible location, the Maui Mall in Kahului. The plan worked! Since 2011, HARF saved the lives of over 5,500 dogs, and 18 horses, giving many deserving animals a second chance at a new beginning.

HARF serves the islands of Maui (p. 165,000), Molokai (p. 7,400), and Lanai (p. 3,100). Most of their life-saving work is conducted on Maui, which is home to HARF's physical operations. Due to a lack of resources to help dogs on Molokai and Lanai, HARF has stepped up and offers assistance to both of these isolated communities.

HARF assists the Molokai Humane Society with re-homing of unwanted dogs by partnering with airlines to fly dogs over to Maui. Sparsely populated Molokai has few re-homing resources and limited education outreach about spaying/neutering, so HARF's assistance in removing dogs and litters of puppies from Molokai has a huge impact on reducing Molokai's dog euthanasia rate.

Lanai has no resources for re-homing dogs. There is a small group of concerned residents who reach out to homeless dogs, one of which is a UPS delivery person who encounters homeless dogs along her routes. HARF, in partnership with private pilots, assists by transporting unwanted dogs from off island to Maui where they are fostered and re-homed/adopted.

HARF has amassed an army of over 670 volunteers, dog foster families and has five paid staff. A testament to the capabilities of the HARF team are HARF's achievements:

- Over the past 11 years HARF reduced the euthanasia rate for dogs on Maui by over 30%
- Spayed/neutered every animal that came through their hands, thereby reducing pet overpopulation by preventing thousands of future unwanted litters. In 2018, they built out a temporary surgery center on their property in Waihe'e allowing for increased nocost/low-cost spay/neuter services to the community
- Coordinated medical services for countless animals in need by establishing their "Phoenix Fund" that serves underprivileged animal owners in the community increasing pet retention and wellness
- Built an impressive volunteer support team of over 670 participants
- Educated thousands of students with Department of Education approved curriculum focusing on treating all living beings with kindness and compassion and instilling responsibility for community and self
- Provided opportunities for Maui's youth at risk through court appointed community service programs – over 600 hours completed in 2019 alone (program temporarily on hold due to COVID – expected to resume in the fall of 2022)
- Provided an "animal retention hotline" assisting pet-owners with medical and behavioral issues so pets can remain in their homes
- Partnered with municipal shelters on Maui and Molokai by accepting animals, thus reducing the economic burden on government funded shelters

 Created a "Houses for Horses" program to help Maui's equines get shelter from the elements as required by County law

Problem or Opportunity

HARF asks for your assistance in completing the project, which is Phase I of the HARF Center project. The barn will house homeless dogs, horses, and livestock; have space for staff and volunteers; provide a base-yard for out-reach programs; provide a place for HARF to bring school children for livestock and dog interaction and education programs; provide a location for on-site veterinary services; provide storage for building materials needed for the "Houses for Horses" program, and much more. In order for HARF to expand their services, they must finally have a physical home.

The barn is slightly over 6,000 square feet, with a twelve (12) foot overhang roof around the entire structure, bringing the total under-roof area to 11,000 square feet. They purchased the pre-fabricated barn from MD BarnMaster, a long-standing company that builds prefabricated barns proven to stand the test of time. The barn package was \$246,000. Additional cost, include installation of the water meter, utilities (electric, water, cable), septic system, permits, architecture plans and engineering with a total cost of construction estimated at \$1,450,000 (see Budget).

HARF's LONG-TERM vision for the land is comprehensive, including building green, incorporating native Hawaiian trees and plants into the landscape, walking trails, a dog park, housing for needy horses, veterinary services for cats and dogs (emphasizing low-cost spay and neuter services), community gathering facilities (including an Education Center), feral cat education services, and a native Hawaiian plant nursery. HARF aims to be a destination for both the local population and visitors to the island. HARF plans to influence each person visiting the Center to take better care of their animals and the earth by building an environment conducive to learning by example.

The raw number of people who will benefit from increasing HARF's capacity via building the HARF Center is potentially the entire population of Maui County (165,000), and the estimated 30,000 dogs and 3,000 horses who reside in Maui. Animals are part of every neighborhood on Maui, and animal related problems affect both animal owners, as well as people living next to people with animals. As individuals learn to provide proper care for animals, everyone benefits.

Currently Maui County has one public animal shelter with limited space for dogs and no space for large livestock animals. Maui's population has grown exponentially over the years, and the one small municipal animal shelter struggles to keep up with the growing number of animals in need, and still has no resources to assist barnyard animals common in our rural community (horses, cows, pigs, goats, sheep, etc.).

Building a barn, as the first building on HARF's property, will allow the agency to greatly increase service to the community by being open for adoptions and general community needs and visits six days a week. HARF's adoption services, school outreach, and Animal Retention Helpline

directly interfaces with all age groups, ranging from Head Start kids, K-12 students, senior citizens, and everyone in-between (tourists included). The barn will also offer much needed support to the municipal shelter by offering a safe haven for homeless, starved, or otherwise neglected barnyard animals.

Activities

HARF's objective is to have the barn constructed and ready for occupancy by the end of 2022. Further objectives are to begin conducting existing programs out of the barn in 2022, and to introduce new programs in 2023.

Phase 1. Building the Building

HARF broke ground on the project in late 2018, and completed the following to date:

Grading of the site Installation of septic system

Foundation (ribbon footings) Installation of fire sprinkler system
Build/assembly of barn Installation of rough-in plumbing

Water meter Installation of electrical

Engineering/Architecture plans Installation of photovoltaic system

Permits

Phase 2. What Happens After the Barn is Built

Once the barn is completed, HARF will move current operations into the barn. These activities include, but are not limited to: dog rescue, adoptions, volunteer opportunities, the Youth-at-Risk court appointed community work service program, high school senior project opportunities, horse rescue, and spay/neuter services.

HARF's current dog capacity fluctuates depending on time of year (fosters take vacations in the summer months and the holidays) and the number of litters of puppies HARF has rescued. Currently, at any given time, HARF's dog population ranges from 20-45 dogs. Dogs may stay with HARF anywhere from a few days to months, depending on age, size, and their "cuteness" factor. The barn will allow HARF to increase capacity by 40 additional dogs, which will increase HARF's lifesaving capacity by nearly 70%, or approximately 750 dogs per year. HARF will also be including cat boarding services within the Multi-Use Barn providing additional operating income of approximately \$81,000 per year.

HARF's current horse rescue capacity is 2 horses at a time, and will increase to stall space for 6 horses, and adjacent pasture, which will provide additional capacity, if needed. HARF will also gain the ability to house other barnyard animals, as needed. HARF's capacity to house horses will increase by 66%.

HARF's long-range plan for their Waihe'e acreage consists of multiple buildings including an education center, a veterinary clinic, dog kennels to house 80 dogs, a large barn, a small barn

specifically designed to provide livestock interaction programs to children, and a dog adoption/office building. HARF's choice to build the large barn as their first building will allow HARF to start all of their desired activities at the get-go, rather than narrowing their focus to a single activity. The barn will allow HARF to do a "little of everything", thereby increasing service to the community on a variety of fronts.

By choosing to build the Multi-Use Barn as the initial building, HARF will benefit from the following:

- HARF will be able to accept and help more animals than they currently can, including dogs, horses, and livestock
- Current dog boarding expenses for "overflow dogs" of \$10,000 (+/-) per year will be eliminated
- Current office expenditure of \$16,500 per year will be eliminated
- The barn will provide a central working space for volunteers and staff, therefore, improving productivity and efficiency
- There will be increased volunteer opportunities
- On-site educational programs can be implemented
- On-site veterinarian services will enhance HARF's ability to closely monitor and treat special needs animals, and animals in critical condition. Not only will this be cost saving to the organization, it will also expedite an animal's rehabilitation time and ultimate adoption

Expected Outcomes

The completion of the large barn, which is the purpose of this request, will mark a significant milestone in the history of HARF, and will significantly streamline the daily operations by providing support services to dog fosterers, will increase adoption days from 1 day a week to 6 days a week, will increase the variety of jobs available to the court appointed Youth-at-Risk workers, increase opportunities for high school students requesting senior projects, increase volunteer opportunities, and increase the number of dogs, horses, and livestock animals that can be saved from homelessness and/or neglect.

In addition, the completion of the barn will allow HARF to provide increased services to the community including safe and reliable cat boarding services, veterinary services for dogs and cats (focusing on low cost spay and neuter services - including services for feral/community cats).

The most striking long-term benefit for the community will be the opportunity for the community (via volunteerism) to create a place, The HARF Center, for people to visit and learn about proper animal care, interact with animals, and learn about Hawaii's native plants. HARF's long-range vision is to create a soothing landscape with abundant shade trees, picnic benches, walking trails for people and leashed dogs, off-leash dog parks, and an education center available for community meetings and functions.

The plan to determine the effectiveness of the barn build project is two-fold. The first goal is to see an increase in rescue, adoption, and spay/neuter numbers, and the second goal is to successfully create a gathering place where people will further develop their concerns for the welfare of animals, nature and our community.

The effectiveness of reaching the first goal will be determined through following the numbers of animals served by HARF before the barn was built versus after the barn is completed, with an expected increase in those numbers. Related to this goal is the concurrent increase in volunteer fosterer numbers as a vital support service to HARF's success.

The second goal of creating a gathering place for people will be measured by the increased hours spent by volunteers, court ordered work service hours completed, and an increase in senior projects. Once the barn is constructed, the land itself will offer a new set of tasks that can be assigned to volunteers and workers compared to the current set of tasks, which are currently limited to adoption event assistance and dog fostering.

Construction

HARF currently owns and holds the deed to ten (10) acres of land in Waihee, Maui, Hawaii, and is currently under construction on Phase I – the Multi-Use Barn. The current status of the barn construction project is as follows:

- Acquisition of land Purchased on April 1, 2017
- Building permit #B 2018-1206 for the Multi-Use Barn issued on October 8, 2018
- Grading and site work *completed*
- Initial foundation work *completed*
- Barn erection/built completed
- Water meter *completed*

- Photovoltaic Electrical System completed
- Electrical *completed*
- Plumbing (rough-in) *in process*

The barn is a custom design by MD BarnMaster, a prefabricated barn company located in Ontario, California that has been in the modular barn business for 30 years, and are experts in their field. The barn is a prefabricated kit, with a cost of \$246,000, which includes the price of shipping the barn materials to Maui. The design of the barn was a collaboration between HARF and the MD BarnMaster design and engineering team. Their assistance in the construction of the barn has been invaluable and ensure the quality of the project outcome.

Operational Plan

Everyday/short-term processes: Day-to-day operation of the Multi-Use Barn will be carried out by the agency's staff and extended volunteer base. The team will address all operational needs with the addition of two (2) Animal Care Specialist. The planned cat boarding operation within the barn will generate sufficient revenue to fund the day-to-day operations. Horse boarding and medical services will provide additional sources of revenue. Current expenses, such as, lease rent and (outsourced) dog boarding will be eliminated thus improving the agency's bottom line.

Long-term processes: Upon completion of the Multi-Use Barn the agency can address the future expansion plan for the property. The Multi-Use Barn is only Phase I of a much bigger vision — the HARF Community Education and Animal Center aka "the Center". The Board of Directors, Board of Champions and the HARF team will work collectively over the coming years to create a

strategic plan and capital campaign for the planned expansion. In the meantime, they will focus on day-to-day operations of their new building and focus on saving more lives than ever before.

Over \$1,200,000 has been raised and invested in the Barn to date and there is no debt on the building. Rising costs and complications related to the COVID-19 pandemic have not only delayed the project, but have added unexpected costs. We are hoping you can fill that gap and bring this project to a completion. In FY20/21, HARF was the recipient of a \$50,000 gift from the County towards the project. Those funds have been spend as agreed and the final report was submitted. We've proven to be good stewards of County funds. This is a one-time request for our "shovel ready" project. We are not asking for ongoing or continued funding.

As the Maui Community Coordinator for Mental Health America of Hawaii, listed in the County budget as the Mental Health Association in Hawaii, we are deeply grateful for the support of the Department of Housing and Human Concerns, the County Budget Office, and the Maui County Council of the important services we provide the Community of Maui County this past budget year.

As we emerge from the COVID-19 Pandemic I am proud to say we have continued to provide multiple services to the Maui County Community this past year. In 2021 we reached 1362 people through our education programs and help calls. This includes 1067 youth and adults trained in self care or bullying and suicide prevention, 146 residents trained in Mental Health and Youth Mental Health First Aid and 74 MPD and FPD officers trained on community mental health resources.

My name is Kalamakū Freitas. I was born and raised in Kona, Hawaiʻi but now reside on Maui where I work as a *Kumu Kaiapuni Hawaiʻi* or Hawaiian Immersion Teacher. I am also a hula student here on Maui. I mahalo you for this opportunity to testify in **strong support** of funding for the Hālau of 'Ōiwi Arts in the proposed FY 2023 budget.

As a graduate of Hawaiian Immersion Education and a hula student for nearly 20 years, I was blessed to have been raised in spaces that are grounded in Hawaiian culture, language, traditions, and values. I feel the lasting impact that this has had on me and how it has helped me to feel a sense of comfort and confidence in functioning in today's Western dominant society as a Hawaiian.

The Hālau of 'Ōiwi Art would provide long-overdue support for the culture and practitioners that make our home so special. Hula – a constitutionally protected traditional and customary practice – is not only integral to Kānaka Maoli, but to the culture of Maui County, as well. It is a nexus for so many of our 'Ōiwi arts and practices to thrive. Hula is a foundational practice that houses a plethora of cultural elements that are vital to the mauli ola Hawai'i or essence of our Hawaiian being. The elements that are preserved through hula include historical events, poetry, cultural practices, and stories, which are all shared through the Hawaiian language. Hula, for so many, is the only opportunity to establish and maintain their connection to their cultural identity. The vast majority of our people are not brought up in Hawaiian Immersion Education, so hula is an avenue for them to gain some of the valuable components that support their journey in knowing and understanding who they are.

Over many decades, Hālau Hula and Kumu Hula have contributed to our community. They recognize the importance of environmental stewardship, educate 'ohana from keiki to kūpuna, tell and celebrate the stories of our home, sing of its beauty, and bring both joy and pride to our larger community. Cultural practitioners like Kumu Hula are experts and leaders of our community. The Hālau of 'Ōiwi Art would support and celebrate these arts and practices.

An investment in Hula is ultimately an investment in the community. Our island once again has the chance to be a leader for our state and global community. Providing a space dedicated to and designed through the lens of Hula creates a visible and reliable space for education, performance, preservation, and excellence of art and culture in our own home.
