A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM, GRANTS AND DISBURSEMENTS FOR BUSINESS DEVELOPMENT AND TECHNOLOGY, SOUTH MAUI ECONOMIC DEVELOPMENT, ENVIRONMENTAL, AND CULTURAL PROGRAMS, NEW CONDITIONAL LANGUAGE FOR LOKAHI PACIFIC FOR KULANIHAKO'I HIGH SCHOOL ACTIVITIES IN THE AMOUNT OF \$15,000

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5816, as amended, "Fiscal Year 2026 Budget," Section 3.B.12.c.(2).(xxiv), Office of the Mayor, Economic Development Program, Grants and disbursements for business development and technology, South Maui Economic Development, Environmental, and Cultural Programs, is amended to add conditional language for Lokahi Pacific for Kulanihako'i High School activities in the amount of \$15,000, to read as follows:

(a) The residency area Councilmember must be consulted before any changes or requests for use of the funds.			
(b) Up to \$40,000 must be for Kihei 4th Friday events.			
(c) Up to \$25,000 must be for the Valley Isle Timing Association dba Maui Raceway Park for renovations and safety upgrades for the Raceway Park.			
(d) Up to \$49,570 must be for ProArts, Inc. for Pono Project.			
<u>(e) Up to \$15,000 must be for Lokahi Pacific for Kulanihako'i High School activities.</u>


