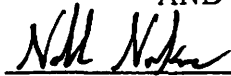
A BILL FOR AN ORDINANCE TO CHANGE THE PA'IA-HA'IKU
COMMUNITY PLAN, (1995) AS AMENDED, LAND USE DESIGNATION
FROM AGRICULTURE TO PUBLIC/QUASI-PUBLIC FOR A 6.097-ACRE
PORTION OF TAX MAP KEY (2) 2-7-007-008, HAMAKUALOA, HAWAII

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Under Chapter 2.80B, Maui County Code, a Community Plan
Amendment from Agriculture to Public/Quasi-Public is granted for a 6.097-acre
portion of the parcel identified for real property tax purposes as Tax Map Key
(2) 2-7-007:008, and more particularly described in the attached as Exhibit "A"
and depicted in Community Plan Map CP-720, attached as Exhibit "B."

SECTION 2. This Ordinance takes effect on approval.

LOT 6-A-1

Being a portion of Lot 6 of Kuiaha-Pauwela Homesteads

Being also a portion of Land Patent Grant 6553 to Florence Wood

Situated at Hamakualoa, Maui, Hawaii

Beginning at the East corner of this lot, on the Southwesterly side of Hana Highway (F.A.P. No. F 32(3)), the coordinates of said point of beginning referred to Government Survey Triangulation Station "KAPUAI" being 6,489.17 feet North and 8,304.02 feet West and running by azimuths measured clockwise from true South:

1. 48° 10' 500.00 feet along the remainder of Lot 6 of Kuiaha-Pauwela Homesteads, being also a portion of Land Patent Grant 6553 to Florence Wood;
2. 93° 10' 185.00 feet along same;
3. 138° 10' 185.00 feet along same;
4. 183° 10' 182.61 feet along same;
5. 228° 10' 512.60 feet along same;
6. Thence along Hana Highway (F.A.P. No. F 32(3)), on a curve to the right having a radius of 11,499.16 feet, the chord azimuth and distance being:

319° 34' 16" 445.08 feet;

to the point of beginning and containing an area of 6.097 Acres.
