Completely fill in the box to the left of your choice with a black or blue pen.

If you vote for more candidates than allowed, your votes for that contest will not be counted.

If you make a mistake, contact your County Elections Division for a replacement ballot. Do not use whiteout.

You will not be issued a replacement ballot once your ballot has been received by your County Elections Division.




Seal and Sign Your Return Envelope

Re-fold your ballot and place in the ballot secrecy sleeve. The ballot secrecy sleeve keeps your votes anonymous while being processed for counting.

Place the ballot secrecy sleeve in the return envelope.

SIGN and seal the return envelope. Your ballot will not be counted without your signature.



Return Your Ballot

The return envelope is pre-addressed and postage-paid.

Your voted ballot must be received by the County Elections Division by 7:00 pm on Election Day, August 8, 2020.

When dropping your ballot in the mail, send it 3 days prior to Election Day to ensure it is received by the deadline.

Alternatively, places of deposit are established 5 business days prior to Election Day to drop off your voted ballot.

Need Assistance?

You may receive voting assistance from a person of your choice excluding your employer or agent of that employer, agent of your labor union, or a candidate for any office that is listed on the ballot.

Hawaii conducts a single party Primary Election to nominate the candidates who will represent each party in the General Election. Everyone may vote in the Office of Hawaiian Affairs and County Contests found on the backside of the ballot.



What's next?

- ▶ After a voter has completed their ballot, they should insert it in the privacy sleeve provide in their ballot package. Then, seal that in the return envelope, sign the return envelope, and send that envelope back to us.
- ▶ Members of the public may send in their return envelopes with their ballots by mail immediately (postage has already been paid).
- ▶ Per the statewide proclamation dated May 15, Voter Service Centers will open on July 27, 2020. Voters may drop off their return envelopes at the Voter Service Centers once they open.
- ▶ Also per the statewide proclamation, additional places of deposit will open on August 3, 2020. Voters may drop off their return envelopes at these places of deposit once they open.
- ▶ We must receive your ballot by 7:00 P.M. on August 8, 2020.

Voter Service Centers

- ▶ Open July 27 – August 8, excluding Sunday
- ▶ Open 8:00 A.M. – 4:30 P.M., except on Election Day
- ▶ Will operate from **7:00 A.M. to 7:00 P.M. on Election Day (August 8)**
