SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2025 BUDGET (ESTIMATED REVENUES AND OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM, GRANTS AND DISBURSEMENTS FOR CULTURE, ARTS, AND TOURISM)

On behalf of the Office of Economic Development, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI, ESTIMATED REVENUES AND OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM, GRANTS AND DISBURSEMENTS FOR CULTURE, ARTS, AND TOURISM."

The purpose of the proposed bill is to amend the Fiscal Year 2025 Budget to increase Carryover/Savings in the General Fund and Total Estimated Revenues by \$55,285 and add a new appropriation to Office of the Mayor, Economic Development Program, Grants and disbursements for culture, arts, and tourism for Alexander Academy in the amount of \$55,285 and increasing the Total Operating Appropriations and Total Appropriations by the same amount.

The Office of Economic Development was contacted by Chair Alice Lee who informed them that the Alexander Academy has been leasing space from Maui Land and Pine for several years in Hali'imaile but were recently given 30 days to move. The Academy has found space at the Kaahumanu Shopping Center but it will need to be renovated to function as a dance studio. The proposed funds will be used to support the costs of the move as well as the buildout of the new space.
