APPROVING THE APPOINTMENT OF GINA M. YOUNG AS THE DIRECTOR OF THE EAST MAUI REGIONAL WATER AUTHORITY

WHEREAS, by letter dated June 28, 2024, Jonathan Likeke Scheuer, Chair of the East Maui Regional Community Board, appointing authority, notified the Council that they are appointing Gina M. Young as the Director of the East Maui Regional Water Authority; and

WHEREAS, Charter Section 8-19.4 provides that, "regional directors are appointed by the applicable regional community board with the approval of the council, and may be removed by the applicable regional community board with approval of the council, or directly by a two-thirds vote of the entire membership of the council"; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That it approves the appointment of Gina M. Young as the Director of the East Maui Regional Water Authority, effective October 1, 2024; and
- 2. That certified copies of this Resolution be transmitted to the Mayor, Managing Director, and East Maui Regional Community Board.
