

RELATING TO THE APPOINTMENT OF TANYA ~~GRIEG~~ TO
THE MAUI COUNTY CULTURAL RESOURCES COMMISSION

WHEREAS, by correspondence dated May 25, 2018, Acting Mayor Keith A. Regan notified the Council he nominated Tanya ~~Grieg~~ to the Maui County Cultural Resources Commission for a term expiring on March 31, 2022, to fill a vacancy replacing Timothy Bailey, pursuant to Sections 2.40.110 and 2.88.030, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,


BE IT RESOLVED by the Council of the County of Maui:
