UNDER RULE 9(B), RULES OF THE COUNCIL, SUSPENDING RULE 15(A) FOR COMMITTEE REFERRAL OF BILL 118 (2025) ON THE COMMISSION ON CHILDREN AND YOUTH

WHEREAS, at its meeting of August 26, 2025, the Council referred to its Government Relations, Ethics, and Transparency Committee Bill 118 (2025), entitled "A BILL FOR AN ORDINANCE REPEALING CHAPTER 2.39, MAUI COUNTY CODE, ON THE COMMISSION ON CHILDREN AND YOUTH"; and

WHEREAS, under Rule 15(A), Rules of the Council, if a bill is not posted on a committee-meeting agenda within 90 days of referral to a standing committee, it will be automatically referred to the committee chaired by the introducing councilmember; and

WHEREAS, Bill 118 was introduced by Councilmember Tamara Paltin, who chairs the Council's Disaster Recovery, International Affairs, and Planning Committee; and

WHEREAS, the GREAT Committee's deadline to schedule Bill 118 under Rule 15(A) is November 24, 2025; and

WHEREAS, under Rule 9(B), Rules of the Council may be suspended by a two-thirds vote of the Council for as long as necessary; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That, under Rule 9(A), Rules of the Council, it suspends Rule 15(A), Rules of the Council, for committee referral of Bill 118 (2025) on the Commission on Children and Youth;
- 2. That the suspension expires at noon on January 2, 2027; and
- 3. That certified copies of this Resolution be transmitted to the Director of Council Services and its Government Relations, Ethics, and Transparency Committee.
