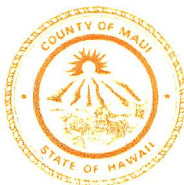

**SUBJECT: AMENDMENTS RELATING TO ACT 298 (2022),
REGISTRATION OF VEHICLES**

On behalf of the Department of Finance, I am transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 3.25.030, MAUI COUNTY CODE, RELATING TO HIGHWAY BEAUTIFICATION FEE."

The purpose of the proposed bill is to amend Section 3.25.030, Maui County Code, in accordance with ACT 298 (2022). The use of the funds collected from the Highway Beautification fee is expanded to include the ability to mitigate and address the impacts of tourism-related traffic congestion. ACT 298 also allows for the fee for all vehicles, to be set by ordinance, at a maximum of \$10 annually.

2. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX B, REVENUES - FEES, RATES,

ASSESSMENTS AND TAXES, DEPARTMENT OF FINANCE, SPECIAL
REVENUE/TRUST AND AGENCY FUND, HIGHWAY
BEAUTIFICATION.”

The purpose of the proposed bill is to amend Appendix B, Revenues – Fees, Rates, Assessments and Taxes for the Department of Finance, Highway Beautification Fee, by increasing the fee for U-drive motor vehicles from \$1 to \$10, effective January 1, 2023.

3. A proposed bill entitled “A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2023 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES – SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2023, HIGHWAY BEAUTIFICATION AND DISPOSAL OF ABANDONED OR DERELICT VEHICLES REVOLVING FUND.”

The purpose of the proposed bill is to amend Appendix A – Part II of the Fiscal Year 2023 Budget by amending the title of the Highway Beautification and Disposal of Abandoned or Derelict Vehicles Revolving Fund to read “Highway Beautification, Abandoned Vehicle, and Tourism-related Traffic Congestion” Revolving Fund.

ACT 298, relating to registration of vehicles, was signed into law on July 12, 2022 by Governor David Y. Ige and takes effect on January 1, 2023. Therefore, the proposed bills listed above shall be effective January 1, 2023.

A BILL FOR AN ACT

RELATING TO REGISTRATION OF VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-51, Hawaii Revised Statutes, is
2 amended by amending subsection (b) to read as follows:
3 "(b) This part shall be administered by the director of
4 finance in conjunction with the requirements of sections 249-1
5 to 249-13 and shall entail no additional expense or charge to
6 the person registering the ownership of a motor vehicle other
7 than as provided by this section or by other laws; provided that
8 for each new certificate of ownership issued by the director of
9 finance under section 286-52, the director of finance may charge
10 a fee which shall be deposited in the general fund. The fees
11 charged to issue a new certificate of ownership shall be
12 established by the county's legislative body.

13 Notwithstanding any other law to the contrary, an
14 additional fee of not more than [~~\$1 for each certificate of~~
15 ~~registration for a U-drive motor vehicle and~~] \$2 for each
16 certificate of registration for all [~~other~~] motor vehicles may
17 be established by ordinance and collected annually by the



1 director of finance of each county, to be used and administered
2 by each county:

3 (1) For the purpose of beautification and other related
4 activities of highways under the ownership, control,
5 and jurisdiction of each county; ~~[and]~~

6 (2) To defray the additional cost in the disposition and
7 other related activities of abandoned or derelict
8 vehicles as prescribed in chapter 290. For the
9 purposes of this paragraph, other related activities
10 shall include but need not be limited to any and all
11 storage fees that are negotiated between each county
12 and a towing company contracted by the county to
13 remove and dispose of abandoned or derelict
14 vehicles~~[-]~~; and

15 (3) To mitigate and address the impacts of tourism-related
16 traffic congestion.

17 The \$2 fee established pursuant to this subsection for
18 certificates of registration for all motor vehicles ~~[other than~~
19 ~~U-drive motor vehicles]~~ may be increased by ordinance up to a
20 maximum of \$10~~[- provided that all amounts received from any fee~~
21 ~~increase over \$2 shall be expended only for the purposes of~~

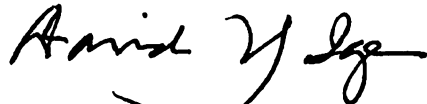


1 ~~paragraph (2)]~~. The moneys so assessed and collected shall be
2 placed in a revolving fund entitled, "the highway beautification
3 ~~[and disposal of abandoned or derelict vehicles]~~, abandoned
4 vehicle, and tourism-related traffic congestion revolving
5 fund". "

6 SECTION 2. Statutory material to be repealed is bracketed
7 and stricken. New statutory material is underscored.

8 SECTION 3. This Act shall take effect on January 1, 2023.

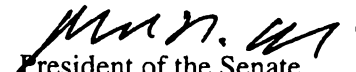
